C. Insurance Renewal

D. Tiny Homes

Mr. Greg Iiams gathered information on "Tiny Homes" as requested by Mayor Reames. Mr. Iiams reported that there is no real definition of a Tiny Home under Ohio Legislation. The home can only be a maximum of up to 500 square feet. A lengthy discussion ensued about these homes.

E. Signs

Mr. John Huffman asked about random signs being placed on random corners of the village. The Mayor stated that only political and real estate signs can be placed in the right-of-way. If business place signs around town, they need to get a zoning permit. An elected official has the right to remove signs that are not placed properly or without a permit. If signs are removed, please bring them to Ms. Dianne Gauder.

F. Ms. Dianne Gauder

Ms. Gauder thanked council for coming to the ground break of the Cobble Stone Hotel today. She asked everyone to be aware of the area as a lot of material and equipment will be coming through.
