3. PUBLIC HEARING: WA-015

Final Development Plan request for a HB-S Two-Phase zoned property for the use of Motor Vehicle, Repair and Maintenance

Doc welcomes Project Planner Gary Roberts from Winston-Salem/Forsyth County Planning.

Gary: Sarah, thank you for your service. It has been a pleasure working with you. Best wishes for your next stage in life.

Today is the Public Hearing for WA-015, the Final Development Plan request for a HB-S Two-Phase zoned property for the use of Motor Vehicle, Repair and Maintenance.

(Gary projects maps; Growth Management Areas, Activity Centers, Zoning, Area Plan, Aerial views, street views and building foot print)

The subject property is 1.27 acres located at 3474 Pearl View Drive on the northeast corner of Old Hollow Road and Walkertown Commons Circle. The site is not located within the Salem Lake Watershed; therefore, no Special Intense Development Allocation (SIDA) is required.

The site was rezoned HB-S Two-Phase in 2004. The address assignment is 5212 Walkertown Commons Circle. The proposed site plan is for a 6,729 sq.ft. Mavis Discount Tire. The site will be the first to have curb, gutter and sidewalk on 3 sides. There will be no direct access to HWY 66. The site is within the US 158/NC 66 Activity Center and the recommended land use is commercial.

The Planning Board recommended approval to the Town Council on 4/2 with the condition of: No outside storage of tires.

STAFF RECOMMENDS APPROVAL

Gary: Any questions from the board?

Peggy: What type of sidewalk? Gary: Standard 5' wide sidewalk.

Peggy: Will there be grass between the sidewalk and 66?

Gary: You could request the sidewalk be moved outside the ROW.

Will Swaringen: DOT has a 3.5 ft. minimum.

Wesley: Would the next lot to the east have direct access to HWY 66?

Gary: Probably not.

Wesley: What type of buffer between the two?

Gary: No buffer required between two commercial properties.

Wesley: How far east will 66 be widened?

Scott: To the town limits.

Doc: Who maintains the interior streets on that side of 66?

Gary: An association paid into by the businesses.

Doc: We get a lot of complaints about potholes across the street.

Gary: You could have an agreement up front before approving anymore Final Developments Plans on that side.

Wesley: Is the driveway (to the east) private?

Gary: Yes.

Wesley: Would DOT recognize the driveway when widening?

Gary: Don't know. You could request the driveway becomes a public street.

Wesley: What about the street stub (Pearl View Drive) behind Mavis? How far east does it go? Does it reach the driveway? If it does, it could be used to access the apartments.

Gary: It stops at the property line. It doesn't connect to the driveway.

Doc: The Planning Board recommended the condition: no outside storage of tires.

Scott: Council could make that a condition for approval.

Will: Mavis does not store tires outside, so we would be fine with the condition. Also, moving the sidewalk back away from HWY 66 would work.

With no more questions from council, Mayor Davis opens the **Public Hearing** for those wishing to speak for or against WA-015 at 7:45.

Peggy: We met last week with guest speaker weatherman Van Denton. He explains that Doppler radar only covers above 10K feet here in Forsyth County. Tornadoes are only 100's of feet above the ground. Well under Doppler coverage. He is seeking funding for the whole state to have Doppler coverage.

Our executive meeting is 5/1. I'll try to get answers to our recreation questions.

Scott: No TAC meeting this month.

We have one Main Street Traffic Study estimate so far.

5. FINANCIAL STATEMENTS

April, 2019

Doc: We haven't completed our tenth month of the year yet, which puts us at ~ 83.3 %. Property tax collection at 98%. Most departments are under, some interests lines over. Revenue "in" at 69%.

Scott: Revenue in is low because on line 10-389-0000, sidewalk, we don't get the

funds until we start our sidewalk project.

Doc: Expenditures "out" is at 56%.

Unrestricted Funds @ \$3,813,346.87 and Restricted Funds @ \$1,073,651.95

for a Grand Total Fund Balance of \$4,886,998.82.
