2018 COLA Increase

Disabled veterans, military retirees and Social Security recipients will see a 2% pay raise in 2018. The pay raise represents the largest increase in Cost of Living Allowance (COLA) since 2012. The first increased payment will show up in the December 2017 pay check.

VETERANS SCAMS

Military Family/VA/Medicare Records Update:

The scammers are contacting veterans claiming to be from the Department of Veterans Affairs (VA), and claim to be reaching out to veterans to update their records with the VA.

The scammers claim it is a new policy of the VA to reach out to veterans via telephone, thus, making the VA a more user-friendly organization.

The goal of the scam is to get a veterans' social security number.

Trading Cash for Benefits Scam:

Another active scam involves scammers attempting to convince veterans to trade their VA benefits for fast cash, often at a fraction of the value of the true VA benefits' value. VA officials have stated in no uncertain terms that such a deal is always bad for the veteran and must be avoided in any form. Any veteran or military family receiving such an offer should report the offer to Operation Protect Veterans by calling [855-800-9023](tel:855-800-9023) to verify legitimacy and help prevent the growth of this scam.

Hurricane Harvey Scam:

The newest "hot scam" preys on the benevolent nature of veterans and military families by asking them to donate money to the victims of Hurricane Harvey.

To avoid such scams, never donate by e-mail, send cash electronically or send funds to an organization name with which you are not familiar. AARP has set up a hotline to help veterans with these scam artists. Any veteran involved in any kind of suspected scam is invited to report it at [877-908-3360](tel:877-908-3360). Also, before sending funds check with Better Business Bureau (<http://www.give.org/charity-reviews/national>) or Charity Navigator (<https://www.charitynavigator.org>) to verify legitimacy of organization

AFTER 18 MONTHS OF STUDY, VA DELAYS ADDING NEW AGENT ORANGE ILLNESSES

After 18 months of review by his department, VA Secretary David J. Shulkin awkwardly announced Wednesday that he plans to “further explore” adding ailments to the list of compensable conditions VA presumes were caused by exposure to Agent Orange and other herbicides used during the Vietnam War.

The decision to punt long-anticipated decisions on Agent Orange-related ailments will disappoint thousands of aging veterans with bladder cancer, hypothyroidism, Parkinson-like tremors and hypertension (high blood pressure).

Veterans and survivors were hopeful some or all of those conditions would be added to VA’s presumptive list of ailments linked to wartime herbicides, based on the latest and final review of medical and scientific literature on Agent Orange from the National Academy of Medicine (formerly known as the Institute of Medicine).

Instead, on the Nov. 1 deadline date that VA itself had set for this packet of decisions, Shulkin issued a brief statement at 6 p.m. promising only more delay

“After thoroughly reviewing the National Academy of Medicine (NAM)’s latest report regarding veterans and Agent Orange, and associated data and recommendations from [VA’s] NAM Task Force, I have made a decision to further explore new presumptive conditions for service connection that may ultimately qualify for disability compensation. I appreciate NAM’s work and the commitment and expertise of [my] Task Force, and look forward to working with the [Trump] administration on the next steps in the process.”

A last sentence, not attributed to Shulkin, explained that the VA “will begin work with the administration to concurrently conduct a legal and regulatory review of these potential presumptive conditions for awarding disability compensation to eligible veterans.

A spokesman for Rep. Phil Roe (R-Tenn.), chairman of the House Veterans Affairs Committee, said he is reviewing VA’s announcement. But Roe “believes veterans waiting for a final decision deserve certainty, and [he] hopes Secretary Shulkin will work quickly to finish the legal and regulatory reviews.”

NAM delivered its report, *Veterans and Agent Orange: Update 2014*, to VA in March last year, after reviewing medical and scientific literature published from Oct. 1, 2012, through Sept. 30, 2014. NAM found evidence to support changing the strength of association between herbicide exposure and several ailments.

For bladder cancer and hypothyroidism, it found “limited or suggestive” evidence of an association to herbicide exposure, an upgrade from “inadequate or insufficient” evidence found earlier. For some ailments, including Parkinson’s and ischemic heart disease, limited or suggestive evidence has been judged strong enough to add the illnesses to the presumptive list. For other diseases, including hypertension, which is common in an aging population, it hasn’t been enough.

The NAM review also looked again at cardiovascular conditions and herbicide exposure. It didn’t upgrade the link to heart ailments but it did affirm limited or suggestive evidence that hypertension is linked to herbicide exposure.

It also studied whether conditions with Parkinson’s-like symptoms should fall into the same limited or suggestive category as Parkinson’s disease itself. NAM found “no rational basis” for excluding Parkinson-like symptoms from the same risk category. Parkinson’s disease was added to VA’s presumptive list in 2010. By late summer this year, Shulkin promised a decision on new ailments to the presumptive list by Nov. 1. Weidman said he suspects the White House’s Office of Management and Budget blocked any plan to add new ailments to the list.

Weidman said members of Vietnam Veterans of America “are going to be really angry” with more delay, because “there is probably enough evidence now for the Secretary to declare other ailments” as tied to Agent Orange exposure, “glioblastoma first among them.” And sailors and Marines who served aboard ship off Vietnam, the Blue Water Veterans, should have been deemed eligible like ground forces for compensation for presumptive ailments long ago, Weidman said.

“The ball is now in Trump’s court,” he added. “It’s not something now that Obama did or did not do.”
