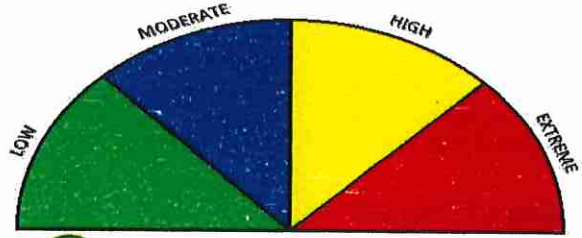


Public Use Restrictions During Fire Season

<p>Use of power saws. When allowed each saw is required to have one shovel and one fire extinguisher of at least 8-ounce capacity. <p>Cutting, grinding, and welding of metal. <p>Use of any other spark-emitting internal combustion engine not mentioned. When able, activities should be conducted in a cleared area* that has a charged garden hose, or one 2.5 pound or larger fire extinguisher available.</p>	<p>ALLOWED ANYTIME</p>	<p>SHUTDOWN REQUIRED BETWEEN 1:00 PM – 8:00 PM</p>	<p>SHUTDOWN REQUIRED BETWEEN 10:00 AM – 8:00 PM</p>	<p>NOT ALLOWED ANYTIME</p>
<p>Firefighting equipment is required while traveling, except on state highways, county roads, and driveways. Equipment includes: one shovel and either one gallon of water or one 2.5 pound or larger fire extinguisher. *Cleared area means an area cleared of all flammable vegetation and debris in a 50' radius.
