



Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

**Premier Class Information**

Dogs with an AX title are eligible to enter Premier Standard Regular. Dogs with an AX or AXP title are eligible to enter Premier Standard Preferred. Dogs with an AXJ title are eligible to enter Premier Jumpers with Weaves Regular. Dogs with an AXJ or AJP title are eligible to enter Premier Jumpers with Weaves Preferred. Dogs with Regular titles may crossover to the Premier Preferred level as noted above.

**MEASURING and HEIGHT CARD INFORMATION**

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog *before* its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

## MOVE UPS

Deadline for pre-trial moveups is Monday, November 7, 2016 at 6 p.m. Notification of moveup must be in writing (e-mail okay). Send move up information to Jo Ann Mather 9625 – 101<sup>st</sup> Ave NE, Arlington, WA 98223 [windgoldats@frontier.com](mailto:windgoldats@frontier.com)  
Day to day moveups must be turned into the score table within 30 minutes of completion of judging.

There will be no wait list offered at this trial.

## DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

## OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors on a dirt surface

## Special Entry Fee for Junior Handlers

The entry fee for dogs handled by Junior Handlers will be \$10 per run. The dog **MUST** be handled by the Junior, who **MUST** have an AKC Junior Handler number.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. **Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$5.00 collection fee (optional) to the amount of each returned check.

*On line entries will be accepted through [www.r2agilityonline.com](http://www.r2agilityonline.com). No on line or hand delivered entries during first 48 hours of opening.*

## COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

## RIBBONS, AWARDS, AND PRIZES

Ribbons will be awarded in each jump height division in each class as follows:

*First Place*.....*Blue*  
*Second Place*.....*Red*  
*Third Place*.....*Yellow*  
*Fourth Place*.....*White*  
*Qualifying Score*.....*Dark Green*

A New Title rosette will be awarded to all dog and handler teams finishing a title. A rosette and decorated bar will be awarded to all dog and handler teams that attain their MACH or PACH. A new title rosette will be presented to dogs earning their PAX.

## NOTICE TO EXHIBITORS

**SAFETY, BEHAVIOR and LIABILITY --** The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

**It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Sno-King Agility Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Sno-King Agility Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Sno-King Agility Club or any official thereof.

**All dogs must be on leash** at all times when on trial grounds except when in the designated warm-up area or competing on the course.

**REFUNDS -- No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

**Bitches in season** are not permitted to compete in Agility Trials. As such, the club will refund 75% of the entry fee paid for bitches unable to compete.

**NO REFUNDS will be given in the event of injury of dog or handler or in the event of personal conflicts.**

## RINGSIDE

**Dogs may arrive** any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

**Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**VENDORS**

If you would like a vendor space, please contact the trial chair for more information. All vendors will be outside, due to limited space.

**This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.**

**ADDITIONAL SITE INFORMATION**

**Crating** – As you know, crating at Argus is very tight. We ask that you respect this and stack crates when possible and attempt to adhere to the crating arrangement we have used in the past. We will be setting aside some space for Novice exhibitors. Absolutely no exercise pens are to be set up in the arena. We also are asking that parking to the arena be reserved for those who crate out of their vehicles.

**Food** will be available gratis for workers and for others by donation. If you are not working, please do not eat until we are assured the volunteers have gotten to eat. There are no restaurants or fast food vendors close by.

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Turn right immediately onto SE Green Valley Road (just past Neely Mansion) Go approximately 7 miles to 212<sup>th</sup> Ave SE (first 4-way intersection after getting on SE Green Valley Rd. Turn right and cross the bridge. Turn left into Argus driveway just past the bridge.

From I-405 Southbound. Go south on Maple Valley Highway (SR 169) into Black Diamond. Turn right on Roberts Road (look for Coal Car). Go approximately 4 miles. Turn left onto 218<sup>th</sup> Street. At the bottom of the long hill is a stop sign. NOTE Cross traffic does not stop. Cross bridge and turn left into Argus Ranch

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend, and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

### INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner? \_\_\_\_\_
