ARTICLES OF INCORPORATION of the O'CONNOR TRACT CO-OPERATIVE WATER COMPANY

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, a majority of which are citizens and residents of the State of California, have this day associated ourselves together for the purpose of incorporating under the laws of the State of California, a non-profit corporation, pursuant to the provisions of Title XXII of part IV of Division First of the Civil Code of the State of California; and we hereby certify:

FIRST: That the name of said corporation is "O'CONNOR TRACT CO-OPERATIVE WATER COMPANY."

SECOND: That the purposes for which it is formed are: To receive title to the water system now installed in what is known as the O'Connor Tract, said tract being shown on the map entitled "The Charles Weeks Poultry Colony, Fourth Addition to Runnymede," which Map is of record in the office of the County Recorder of San Mateo County, California, in Book 10 of Maps, at Page 28; to extend the said water system as necessary and maintain and operate the same for the purpose of furnishing water to the members of this corporation on their lands in said tract for domestic, stock watering and irrigation use; to buy, lease, or otherwise acquire, real and/or personal property, and/or rights therein, necessary or convenient for the aforesaid purposes, and to sell, lease, or otherwise dispose of the same, to borrow money and give security therefor by means of mortgage, deed of trust or other lawful means; to levy and collect assessments upon its members for the purpose of raising a fund out of which to meet the expenses incurred and to be incurred in carrying out the purposes of this corporation, and to take all lawful means for the enforcement of such collection: and to exercise all of the powers of said Title XXII, and the powers necessarily incident thereto, and, also all other powers granted to private corporations by the laws of the State of California not inconsistent with those granted by said Title; and to do and perform any and all other acts which may be, either necessary for, or proper or incidental to, the exercise of any of the foregoing powers; provided, that the purposes for which this corporation is formed and the power of these Articles herein granted shall in no wise ever be construed, exercised or permitted to function as a public utility, nor shall any of the water owned by said corporation or any water that may hereafter be developed from any water system owned by said corporation, be sold, furnished, or delivered to any person, firm or corporation, other than to the members of the O'Connor Tract Co-Operative Water Company.

THIRD: That the place where its principal business is to be transacted is in Runnymede, County of San Mateo, State of California.

FOURTH: That the term for which it is to exist is fifty (50) years from the date of its incorporation.

FIFTH: That the number of its directors shall be five, and the names and residences of those selected for the first year and until their successors have been elected, and shall have accepted office, are:

SIXTH: That the voting power and the property right and interests of the members of the corporation shall be unequal; that the sole qualification for membership in this corporation shall be the holding of the legal title to land within said tract; that any person now holding, or who shall hereafter hold, the legal title to any land in said tract, shall be entitled to a certificate of membership in this corporation; provided, however, that such certificate of membership shall lapse when the owner thereof is no longer the holder of the legal title to land in said tract. That each member of this corporation shall have votes upon all matters that shall come before this corporation in proportion to the area of land in said tract owned, of record, by him, one vote being allowed for each one-fourth acre so owned, and proportional fractions of votes for smaller areas; and each member of this corporation shall have such an interest in all of the property of this corporation as is represented by the ratio of the number or votes to which such member is entitled to the total possible number of votes that may be voted by all the members of the corporation; provided, however, that such interest is, and shall be, appurtenant to the land within said tract owned by such member.
