



CLASS OF 2020 SUBSTANCE FREE GRAD NIGHT PARTY INFORMATION AND GUIDELINES

The Class of 2020 Grad Night Party will be held starting on Sunday June 7, 2020.

NO ALCOHOL, TOBACCO OR OTHER SUBSTANCES (DRUGS) ARE PERMITTED.

DO NOT BRING: purses, bags, backpacks, cell phones, cameras, electronics, watches, or money. They are NOT ALLOWED and will be confiscated until the end of the event at 5:00 am. All personal items (hair dryers, personal hygiene and first aid supplies) will be provided.

ONLY Registered Southridge High School Seniors may attend the Grad Night Party.

The party will be held away from the Southridge High School Campus. Bus transportation will be provided to and from the party from Southridge High School. Students may register for a specific color bus of their choosing with their friends during both lunches in May.

Graduates should dress casually in comfortable active wear: shorts, sweatpants, or jeans and non-marking athletic shoes.

Graduates **MAY NOT WEAR SWEATSHIRTS OR JACKETS.**

BRING A SWIMSUIT, TOWEL & SOCKS AND YOUR SCHOOL ID WITH YOU!!!

Graduates check in at SOUTHRIDGE High School on Sunday, June 7, 2020, at 9 pm in the Community Room. All Graduates must be checked in by 9:30 pm. Graduates will be returned to campus by 5:00 am Monday June 8th, 2020. All Graduates must ride the bus to and from the Grad Night Party.

All Graduates will be breathalyzer tested and put through a pat down. If a student appears “under the influence” at check-in or at any other time during the Grad Night Party, Parent/Guardian will be called to take Graduate home. Any inappropriate behavior will be disciplined by immediate removal from the bus or party. Parent/Guardian will be called to pick up their Graduate. **NO RE-ADMITTANCE UNDER ANY CIRCUMSTANCES.**

No refunds will be granted under any circumstances.

Graduates will not be permitted to leave the Grad Night Party once they have checked in at Southridge. In the case of illness, injury or emergency, Parent/Guardian on listed emergency contact will be contacted to pick up Graduate from the party venue. The Graduate will NOT be able to return to the party.

Paperwork **MUST** list ALL allergies and medications needed during the Grad Night Party.

Any Medication needed must be checked in to the Nurses at the Grad Night Check In at Southridge High School.

PLEASE NOTE: Because Grad Night Party Attendees will be tired upon conclusion of the party, Parents/Guardians are strongly encouraged to drive their Graduate to/from Southridge for check-in/pick up the following morning. Buses will return to Southridge Main Entrance parking lot by 5 am on Monday June 8th, 2020. Students may drive their cars to Southridge and park over night, but we cannot guarantee security will be provided overnight for their vehicles.

A cell phone number will be available for parents to call in the event of an emergency. The Grad Night Party Event Venue is kept confidential and only released to Grad Night Volunteers 1 hour prior to Event Set Up the Day of the Grad Night Party.

- *"This liability includes all damages caused by the participant either to the facilities or individuals."*
- *"Each person attending the party agrees to accept full responsibility for his/her actions at the party."*

**GRAD NIGHT PARTICIPANT RELEASE AND WAIVER OF LIABILITY,
ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

The undersigned hereby certifies that I am the legal parent/guardian of _____, a graduate (hereinafter the "PARTICIPANT") participating in GRAD NIGHT activities at an undisclosed location (hereinafter the "HOSTING FACILITY"). In consideration of being permitted to enter the HOSTING FACILITY'S premises and being granted access to the HOSTING FACILITY'S amenities and services, and being permitted to participate in any of the GRAD NIGHT activities at the HOSTING FACILITY, the undersigned:

1. Agrees that he/she will instruct the PARTICIPANT that he or she must adhere to the HOSTING FACILITY'S Rules of Conduct and may not be under the influence of, or use, illegal drugs, tobacco or alcohol prior to or during the event.
2. Agrees that any damages caused by the PARTICIPANT will be paid by the undersigned to the owner(s) of the damaged item(s).
3. Represents that the participant has medical coverage and has been released to participate in the activities conducted during GRAD NIGHT by his/her personnel physician and understands that in the event of a medical emergency, the undersigned or the listed emergency contact person will be notified immediately, and if neither are available for consultation, grants permission to the HOSTING FACILITY to obtain medical treatment as deemed necessary.
4. Hereby releases, waives and discharges the HOSTING FACILITY, including its officers, agents, employees, managers, independent contractors, parent organizations, subsidiaries, affiliates and personnel ("Releasees") from, and agrees and covenants not to sue Releasees for, any claim, liability, or demand of any kind or on account of any personal injury, temporary or permanent disability, death, property damage, or other damages to PARTICIPANT or the undersigned, whether caused by the negligence of Releasees or otherwise, resulting from or in any way associated with the PARTICIPANT or undersigned's entry on the HOSTING FACILITY'S premises or use of the HOSTING FACILITY'S amenities and services, or participation in any of the GRAD NIGHT activities at the HOSTING FACILITY. Further, the undersigned agrees and covenants to indemnify Releasees for, and hold Releasees harmless, from any such claims, liabilities or demands.
5. HEREBY VOLUNTARILY ASSUMES ALL RISKS of personal injury, including temporary or permanent disability or death, property damage, economic losses, and/or other damages to PARTICIPANT and/or undersigned resulting from or in any way associated with the PARTICIPANT or undersigned's entry on the HOSTING FACILITY'S premises or use of the HOSTING FACILITY'S amenities and services, or participation in any of the GRAD NIGHT activities at the HOSTING FACILITY.
6. Acknowledges and agrees that this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT is intended to be, and is, a complete release of any responsibility of Releasees for personal injuries and/or temporary or permanent disability or death and/or property loss/damage sustained by the PARTICIPANT or undersigned while on the HOSTING FACILITY'S premises or while using the HOSTING FACILITY'S amenities and services, or while participating in any of the GRAD NIGHT activities at the HOSTING FACILITY; and undersigned further acknowledges and agrees that it is specifically intended to and does include release, waiver, assumption of risk and indemnity as to premises liability claims such as (by example, not limitation) slip & falls and/or trip & falls at the HOSTING FACILITY.
7. Understands that this waiver and release is intended to be as broad and inclusive as permitted by the laws of this state and that if any portion of this waiver and release is held invalid, the balance shall continue in full legal force and effect.

The undersigned confirms that he/she has read and understands this GRAD NIGHT RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT and acknowledges and agrees to its terms, and signs it freely and voluntarily.
