Technical Advisory Subcommittee – Amy Kahler stated that at a recent Metro Group meeting. representatives discussed the new Regional Technical Advisory Committee's mission, responsibilities, members and deliverables. The Technical Advisory Committee will evaluate the current regional water system and thoughtfully plan for a water system that cost-effectively meets the needs of central lowa customers for the next twenty years (2035). The Technical Advisory Committee will advise CIRDWC and/or community councils and boards on water system capital improvements necessary to provide and maintain an infrastructure to meet growing water demands in the central lowa region. The Technical Advisory Committee will meet monthly or as necessary. Meeting dates and times shall be communicated to all stakeholder communities. Members have been recommended by CIRDWC and are initially identified as 1) water producers, and 2) water systems serving communities expecting growth in population. Members have been identified as follows: City of Altoona, City of Ankeny, City of Johnston, City of Norwalk, City of Waukee, Des Moines Water Works, Urbandale Water Utility, and West Des Moines Water Works. While these members have been identified as active participants, needs and interests of all customers of DMWW's Core Network will be considered and represented in discussions and plans. Participants may be water utility managers, consulting engineers, planners, or similarly qualified individuals who are able to attend regularly scheduled committee meetings and provide input throughout the planning process. The Technical Advisory Committee will keep stakeholders of Des Moines Water Works' Core Network apprised of their evaluations. In addition, the Technical Advisory Committee will review and provide input on issues identified as DMWW's monthly board agenda items. It was agreed upon that members will have their representative(s) named by July 15, with the first meeting taking place late July or early August.
