I covenant not to make or bring any such claim against the Team or any of the Released Parties in any court, tribunal, or regulatory proceeding, and forever release and discharge the Team and all Released Parties from liability under such claims.
- 4. I shall defend, indemnify and hold harmless the Team and the Released Parties against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs or expenses of whatever kind (including reasonable attorneys' fees), fees and the costs of enforcing any right to indemnification hereunder and the cost of pursuing any insurance providers, arising out of or resulting from any claim of a third party related to my actions or inactions while engaged in the Activity.
