**ORDER SETTING HEARING TO CONSIDER  
THE RECEIVER'S PROPOSED PLAN OF DISTRIBUTION  
AND ANY OBJECTIONS TO THAT PROPOSED PLAN**

The Court hereby sets a hearing for October 18, 2016, at 2:30 p.m., in Courtroom 1705, (the "Hearing") where the Court will consider the Receiver's Motion to Approve Plan of Distribution (the "Plan of Distribution") [166] and any objections to the Plan.

Any claimant who is dissatisfied with the Receiver's claim determination or the Plan of Distribution may file an objection with the Court. Objections must be filed in writing by the claimant with the Clerk of the District Court, United States District Court for the Northern District of Georgia Atlanta Division, Richard B. Russell Federal Building, 2211 United States Courthouse, 75 Ted Turner Drive, SW,

Atlanta, GA 30303-3309. The claimant must also send a copy of the objection to the Receiver's office at 999 Peachtree Street, N.E., Suite 1120, Atlanta, Georgia 30309.

Objections must be received by the Court and the Receiver on or before October 7, 2016. At a minimum, any objection must contain the following:


- (1) A caption setting forth the name of the case, the names of the plaintiff and defendants, and the name of the Court and case number; this information is all provided in the caption on Page 1 of this Order;
- (2) The name of Claimant and a description of the grounds for the claim and the amount of the Claim;
- (3) A concise statement stating why the Claim should not be disallowed or modified under the Plan of Distribution and why another distribution method would be more equitable for the Claimants as a whole;
- (4) All documentation or other evidence upon which Claimant will rely in opposing the Claim determination and Plan of Distribution; and
- (5) The physical address, email address, and phone number for Claimant to which the Receiver may communicate with the Claimant.

Claimant may, but is not required to, retain the services of an attorney to file an objection. If no objection is received, the Court may enter an Order allowing or

disallowing the claims in the Plan of Distribution. If a claimant makes an objection to the Plan of Distribution, the claimant must be present at the Hearing to assert the claim. If a claimant does not attend the Hearing, the Court may enter the relief requested by the Receiver in the Plan of Distribution. An objector shall have the burden of proof for their claim at the Hearing.

The Receiver shall provide notice of the Hearing to claimants known to the Receiver. Notice shall be by mail and by posting notice of the Hearing on the Receiver's website.
