

**TAX LEVY ORDINANCE**  
**TOWNSHIP**  
**ORDINANCE No. 2020-004**

An ordinance levying taxes for all town purposes for Collinsville Township, Madison County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of Collinsville Township, Madison County, Illinois as follows:

SECTION 1: That the sum of **One Million, Two Hundred Forty Three Thousand, Four Dollars (\$1,243,004)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by state or voted by the people in accordance with the law, for such purposes as:
