Jim Stevens gave the board a few updates on what the Road Department is working on. He gives the update on the Sanitary Sewer Project. The rain has created a road block to getting mowing completed. He explains the last few weeks have mainly consisted of storm damage repair as well as clean up. In the last 2 weeks, the department has taken over 50 loads to the dump just from everything that has been scattered from the storms. Jim would like to start doing preventative tree cutting and trimming. He elaborates on a specific tree that he knows will most likely fall if there is another storm. He would like to get a quote and then present that to the board. Jim presents to the board the need to get mounting lights for the trucks, as these may help with safety, as this is of utmost importance.

Following Jim Stevens is Byron Smith, Police Chief, he touches on a vacant house where he believes people are squatting. A citizen, Mike Blevins, talks to the board about speeding on Ransburg. He would like to see more of the Police Department enforcing the speed more harshly to drivers. Byron expressed to the board about maybe getting a speed sign put up on the street.

Next up, the Fire Department, Assistant Chief Chas Adams, starts off with giving some stats. The department took 817 runs; 615 ems and 164 fire runs. He goes on to say, the opioid crisis has hit us. The township had 37 overdoses in Franklin Township, that our EMS team took care of. We are in the first docket of opioid overdoses, which means our township will receive the most Narcan. The state of Ohio sent the department a Grant for \$1000.00 that will be used towards a cot for the new medic. Marathon Petroleum is also granting us \$800 towards a nozzle for a fire truck. Cloves Fire is donating 12 breathing apparatus' and 42 voice amps/42 masks. Assistant Chief Adams answers a question from the audience about the Narcan usage. Adams goes on to explain 20% of people are going to rehabilitation treatment rather than back to drug usage.

John Fleshman makes a motion to add Home Rule on the November 2017 ballot.

Ralph Horn seconded.

John Fleshman makes a motion to not exceed more than \$850.00 for the purchase of a laptop for the office. Fleshman goes on to elaborate why a new one is needed.
