#### **Amana Church Volunteers Plan Summer Trip to Pine Ridge**

About 65 people gathered in the Amana Church Sunday to hear about and see photos of the Pine Ridge community that Amana Church Elders and volunteers have been visiting these past 9 years.

This was the fourth of the church's Winter Symposium which included a variety of talks on Amana community building, links to other communities and community history.

Working with the Pine Ridge charity Re-Member, the Amana Church volunteers have helped build bunk beds, outhouses, handicapped ramps and to winterize homes on the Pine Ridge Reservation in southwestern South Dakota.

The Pine Ridge reservation is about 100 miles from Rapid City. Surrounded by the Black Hills and the Badlands, it is the home of the Oglala Lakota Nation. The reservation is among the largest in the United States. According to Re-Member, the average life expectancy at Pine Ridge is 66.8 years, the lowest in the nation. For men the average life expectancy is just 47 years. The Pine Ridge Reservation has the lowest per capita income in the nation - at about \$8,768. Oglala Lakota County contained within the boundaries of the Pine Ridge Reservation is ranked the "poorest" in the entire nation.

Re-Member seeks to help survival rates and quality of life on Pine Ridge by providing shelter, food, beds, bedding and supplies and by raising awareness bringing volunteers to the reservation to serve and to meet with members of the Pine Ridge community. They're focusing on gardening and self-sustaining food sources to help provide low-cost foods. They also seek to foster a spirit of cooperation and pride in traditions.

Saturday, August 3 – Friday, August 9 Amana Church volunteers will be returning to Pine Ridge. Would you like to join them? If interested please call Kristie Yoder, Tony Berger or Betsy Momany. # NEWS AND NOTES

#### **Clear Creek Amana Girls are State BB Champions**

For the first time in the history of Clear Creek Amana High School, the girls basketball team has won the Iowa State Girls Championship. They captured the 4A title on Saturday, March 3, upending Waverly-Shellrock with a huge 43 - 25 win at Wells Fargo Arena in Des Moines.

Both teams were undefeated going into the matchup but Clear Creek Amana dominated with a precision defense that effectively kept the Go-Hawks of Waverly Shellrock from scoring. The Go-Hawks were just 7 of 49 from the field. That's 14 percent. In previous games the team had been putting up big numbers so this was a significant piece of the victory. And what's telling is that the CCA girls did not let up as they powered to a victory holding the Go-Hawks to just one field goal in the final 10 minutes of play.

As CCA's standout Ava Locklear told the Des Moines Register Saturday, "We knew coming in, it had to be defensive-focused. They're a really good offensive team; their bigs are really skilled and so we knew coming in, we had to lock in on that."

CCA's coach P.J. Sweeney prepared his team perfectly for the game and the CCA Clippers dominated the boards and their opponents. The score at half-time was 24-12. They had 8 blocked shots in the first 16 minutes with Bliss Beck and Locklear earning four each. Coming out strong the second half, CCA did not let up. They finished with 10 blocks and six steals as a team.

On offense the team scored both from 3-point range and in the paint. Averie Lower was team high point leader with 17 points (four were 3 pointers) and four big steals.

Locklear scored 11 points and whopping 19 rebounds with Bliss Beck adding 11 points and 8 rebounds.

The Clear Creek Amana Clippers finished with a perfect 26 – 0 record – the best in program history. Ava Locklear, Averie Lower and Bliss Beck were named to the Class 4A all-tournament team with Locklear earning the team captain award.

Another stat to savor: CCA allowed a measly 34.3 per points per game in tournament play, and just 33 points in the post season. During the season they held opponents to 31 points - making them the top defensive team in 4A girls basketball.

Locklear's 19 big rebounds in the championship game brought her tourney total to 43 - a state tournament 4A record.

This year's victory was particularly sweet as for the past two years P.J. Sweeney and his Clippers made it to the state tournament only to be

are communal. Volunteers work completing construction type tasks though no previous construction experience is needed.

Last Sunday Mike Shoup, Kristie Yoder, Tony Berger, Penni Berger and Betsy Momany shared their photos and memories of past trips.

The photos of sunburnt tall grass meadows and tawny vistas did full justice to the beauty of Pine Ridge. Photos of construction projects, visits to the tribal dance competition and arts fair, meals together at the bunkhouse and work day sack lunches on the wheel rim of trailers gave a picture of the week's activities, while the stories shared explained how important the trips have been to those who have volunteered.

Amana Church volunteers stay at the Re-Member bunkhouse, share in cooking for a group of volunteers that usually numbers about 40 people. They work at the Re-Member workshops and make trips to homes scattered throughout the reservation to install bunkbeds, outhouses and handicapped ramps where needed. Winterizing trailers is important work and requires visiting homes. Sometimes the residents are happy to see them and sometimes they are not. The deep wounds and scars of generations of systemic racism can be hard to overcome.

"I'm always amazed at the resiliency and really, the joy they have. The pride. It puts so much into perspective for me." said Kristie Yoder who has been back to Pine Ridge 8 times.

After discussion the vote was unanimous to recommend the full grant amount of \$2500. THIS IS FOR A GRANT AP-PLICATION. After discussion B. Momany made a motion to approve the application and grant amount as stated. Second by TePoel. Motion carried unanimously.

b. 2024-002. Dennis Zuber/Hanna (Zuber) Kiel/ 4468 V St Homestead/ HP-R / This work is for the east wall of "the old doctors office". Remove old mortar and re-tuckpoint same.
