

AMELIA VILLAGE, OHIO
Ordinance O-2015-60

AN ORDINANCE DESIGNATING RIVERHILLS BANK AS AN ADDITIONAL
DEPOSITORY FOR ACTIVE, INACTIVE AND INTERIM DEPOSITS AND
DECLARING AN EMERGENCY.

WHEREAS, Village Council has determined that it is necessary and in the Village's best interest to appoint an additional depository for the Village's active, inactive and interim deposits, now therefore,

BE IT ORDAINED, by the Council of the Amelia Village, Clermont County, Ohio, a majority of its members concurring:

SECTION I. That RiverHills Bank shall be designated as an additional depository for active, inactive, and interim deposits for Amelia Village.

SECTION II. That the Mayor and Fiscal Officer are hereby authorized and directed to enter into any necessary and proper depository agreements with RiverHills Bank.

SECTION III. Village Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION IV. This Ordinance is hereby declared to be an emergency measure for the preservation of the public peace, health, safety and general welfare of the Village, and for the further reason that it is immediately necessary to approve this at the earliest possible time, in order to comply with the Ohio Uniform Depository Act and to have designated depositories for Village funds. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members elected to Council, the ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

MR. CAMPBELL moved to suspend the rules requiring three readings on three separate dates.
