- -Switch went bad at the south lift station, phase monitor also had to be replaced.

- -Dirt has been leveled at pump house and rock hauled in
- -Ahlers would like an extra tank for diesel fuel for the generators. The STP plant tank is 80 gallons and must be filled daily when its running. He will further into prices for next meeting.

Wegrzyn stated that he feels we need to invest in one.

- -EPA needed 2 more sample tests for the new well as soon as those results are back the well should be ready to use. Albrecht will look at the old well cost depends on where and what is wrong with it.

It was decided to shut her off with the understanding that the bill is paid in full with a \$100 turn on fee charged.
- -Short discussion on the September car show after the new guidelines that have come out the board feels it is best to cancel this year's event.
