UNOFFICIAL MINUTES OF THE EMERGENCY MEETING OF THE TOWN COUNCIL OF UPTON, WESTON COUNTY, WYOMING December 13, 2024

THE EMERGENCY MEETING of the Town Council of Upton, Wyoming, was called to order at 7:00 p.m. on Friday, December 13, 2024 at the Upton City Hall located at 725 2nd Street in Upton, Wyoming.

Present: Mayor Nicholas Trandahl, Council Members Rick Rothleutner, Justin Norman, Tiffany McMillan and Joe Watt. COUNCIL MEMBER NORMAN MOVED, COUNCIL MEMBER MCMILLAN SECONDED a motion to move into executive session at 7:01 p.m. as allowed per W.S. 16-4-405(i) With the Attorney General, city attorney, sheriff, chief of police or their respective deputies, or other officers of the law, on matters posing a threat to the security of public or private property, or a threat to the public's right of access and 16-4-405 (xii) To consider, discuss and conduct safety and security planning that, if disclosed, would pose a threat to the safety of life or property. All ayes, MOTION CARRIED.
