








EXAM QUALIFICATIONS

 Highlights Per WAC 363-116-0751 (scan for full list of qualifications)



- ▶ U.S. Citizen
- ➤ 1600 GT license for at least 2 years prior to application



- ➤ I-2 years command time depending on vessel class (not all command time meets WA State qualification)
- No local knowledge or federal pilotage necessary



EXAM OVERVIEW



- Offered at least every 4 years
- Anonymous process
- Two steps:
 - Written Exam
 - > Simulator Evaluation
- Psychometrically validated
- Ranked waiting list

PSYCHOMETRIC VALIDATION

Psychometrics:



➤ "A branch of psychology concerned with the quantification and measurement of mental attributes, behavior, performance, and the like, as well as with the design, analysis, and improvement of the tests, questionnaires, and other instruments used in such measurement." (APA Dictionary of Psychology, 2019)

Validity:

➤ "The degree to which empirical evidence and theoretical rationales support the adequacy and appropriateness of conclusions drawn from some form of assessment." (APA Dictionary, 2019)



PSYCHOMETRIC VALIDATION (CONT'D)



- Job Task Analysis (JTA):
 - Develops a comprehensive list of skills needed for successful pilotage;
 - Determines test specifications including type of assessment, format, number of items, and length of time
 - > Develops the test blueprint, which outlines how many test questions are needed for each content area; and
 - Clarification of JTA, exam blueprint, local knowledge, and bibliography

WRITTEN EXAMINATION - STEP I

- 100 Questions
- Bibliography and Exam Blueprint provided (application packet)



- Reminder
 - Must pass the Written Exam to be eligible for the Simulator Evaluation portion of the exam.
 - Give equal weight to studying both for the Written Exam and Simulator Evaluation
 - > Study groups are available, if desired



WRITTEN EXAMINATION – REMOTE PROCTORING

- Administered online using a secured testing platform
- Taken at a location of applicants choosing
- All tests taken on April 8, 2024 @ 0900 Pacific Time
- System and Environmental Requirements, such as internet speed, surroundings, and camera will be provided once you are approved by the Board to sit for the exam

SIMULATOR EVALUATION – STEP 2

- Where: MITAGS West (formerly Pacific Maritime Institute (PMI) – Seattle, WA
- When: Beginning the week of April 22



Details:

- General shiphandling skills as a Captain
- Simulator training or experience is not required
- Scheduled to be held in the OSV simulator at MITAGS

Limited guided simulator time (approx. I hour) will be provided prior to Simulator Evaluation

- Entry and Training Contract
- Observation, Training, Evaluation 300+/- Trips
- Federal Pilotage (26 charts)
- ➤ Monthly Stipend \$8,000
- Training Matrix (requirements) 36-month max (average completion is under two years)
- Periodic Deadlines
- Trainee Evaluation Committee (TEC)
- Board of Pilotage Commissioners (BPC)








PILOT TRAINING PROGRAM

- Observation, Training, Evaluation 150 +/- Trips
- Federal Pilotage (1 chart)
- Monthly Stipend or Employment with the Port of Grays Harbor
- ➤ Training Matrix (requirements) 30 Month Max. (average completion is I year)
- Periodic Deadlines
- Trainee Evaluation Committee (TEC)
- Board of Pilotage Commissioners (BPC)


