

On May 22, 2013 I filed a "Complaint of Misconduct" with the 11th Circuit in Atlanta (56 Forsyth St. Atlanta, GA 30303) against District Court Judge M. Casey Rodgers who presided over my case. On July 11 I amended the complaint with another issue.

On July 25 then Chief Circuit Judge Joel Dubina filed an order wherein he restated some of the issues in my complaint, ignored most and answered NONE of the issues I raised. He just said he could not see where she did any wrong.

August 22 I filed a petition for review of his order with the "Judicial Council." Normally these complaints and reviews are rejected in days of weeks but it seems they may have actually read mine and considered it because they did not make a ruling until Dec. 5. when they ruled that they would accept Judge Dubina's order as final. They also did not answer a single one of the issues I raised in my complaint. My legal team said this is normal but it was worth a shot.

Before the entire trial even started over 7 years ago my paralegal friend Richard told me not to expect any justice in the Federal system. He said it was the most corrupt system in the world that he had ever seen and Federal Judges were not really "Judges" at all in the sense the founders of this country envisioned or in the sense that God ordered in His Word. I didn't believe him. In my naivete I was proud to be an American and felt sure that justice would be done and I maintained my innocence. Wow was I wrong! Canadian Conrad Black sure learned about the injustice in the American federal system and has written extensively about it in his books! Harvey Silverglate's book "Three Felonies a Day" is a MUST read for anyone seeking to see how close our "justice system" has become to Hitler's or Stalin's or Mao's.

I didn't know then (but I do NOW!) that one of the key considerations in the federal "justice" system is a doctrine they call "the state's interest in the finality of conviction." See the 1971 Supreme Court case Mackey vs. U.S. for an example. What this means is-they try to never overturn cases because it makes the local judge look bad. Once they get a conviction by whatever means the rest of the federal judges will circle the wagons and try to uphold the conviction at all costs and in spite of all logic or obvious errors. Real honest justice is the LAST thing they consider IF it is considered at all! The founders of this country would start another war if they knew their system of government that they bled and died for had degenerated to this low.

In a Republic like America (America was NOT founded to be a "Democracy." See wallbuilders.com to study the difference!) the blame for this decay of justice must be blamed on the people. The Constitution is an excellent document and the laws of America based on that document are wonderful. (I Tim. 1:8) It is in the enforcement (or lack thereof) that the problem comes in. The people should be vigilant to elect only senators and representatives that understand and plan to obey the Constitution (See my blog Davy Crocket for President on www.2peter3.com) as they all swear to do!

Those elected officials should then only pass laws that are within their Constitutional authority. For example-the Federal government has NO authority to be involved in Education, enforcing drug laws, welfare of any kind, and about 95% of the other areas and departments they have created. They should be closed down asap!

Then, those elected officials have a duty to impeach judges that do not rule by the very Constitution that not only gives them a job and authority but that they swore to uphold. It is VERY rare for a federal judge to be impeached and they know it! That is why they routinely ignore the law and we see rulings contrary to the law like is clear in my case.

I was, of course, disappointed in the Judicial Council's decision to agree with the previous "non answer" I had gotten from Dubina but, my "Ebed" (See Jer. 38) says this is not a big deal. He gets rejections or dismissals of complaints all the time. It will not effect all the other issues I have going in various courts and it will remain part of the permanent record for all of the judges involved until the REAL Judge of the universe Himself reviews "every word" (Matthew 12:34-36) on Judgement Day. THAT day will be VERY interesting! See Appendix #6 of my book, "What on Earth is About to Happen...for Heaven's Sake?" on 2peter3.com.

So, this particular line of attack to get my unjust conviction overturned is at a dead end for now. Since none of the judges involved ever actually answered any of the issues I raised in my complaint there may be some patriotic Americans or some inquisitive reporters or bloggers (who are paying the salaries of these judges) who would want to contact them in their individual capacity to try to get real answers. The "public" needs to know. I will focus on other avenues for now.

The US Attorney in my case was Michelle M. Heldmyer. I have a complaint filed against her in both federal courts where she is accepted to practice- Florida and Colorado. For a quick summary of the real issues in my case see the Colorado one filed Dec. 19. She is due to answer that one soon. I'll keep you posted.
