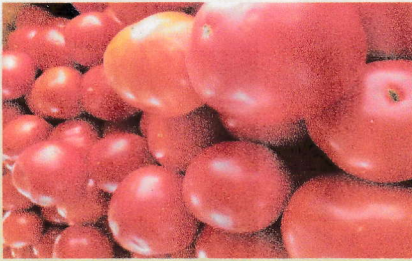


BECOME A SHAREHOLDER IN OUR 2020 CSA

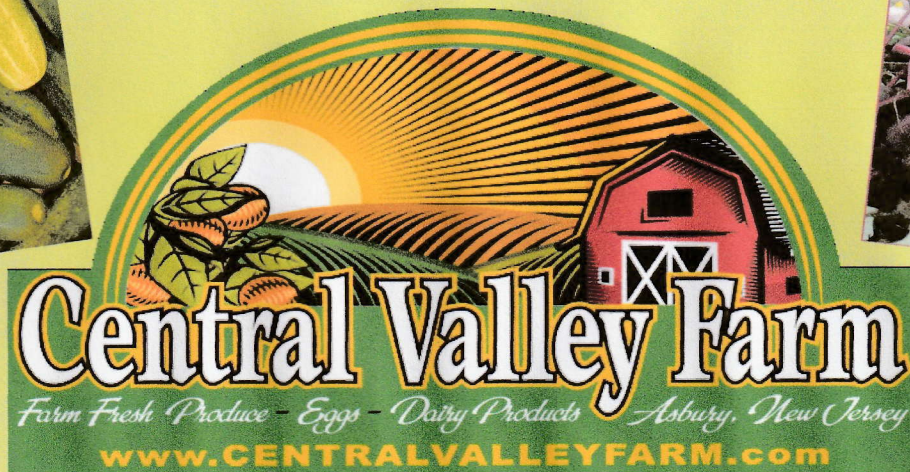


What is a CSA?



A Community Supported Agriculture (CSA) consists of a community of individuals who pledge support to a farm operation where the growers and consumers share the risks and benefits of food production. Our CSA is of a system of weekly pick up, at our farm, of seasonal, naturally grown fruits and vegetables.

Our 2020 CSA is expected to run for 20 weeks from the beginning of June through mid October.

How does our CSA work?

Each week you will pick up your share of freshly picked produce that is currently in season. Typically a weekly share is enough for a family of four. If one share is too much for you, a great option is to split a share with friends or a family member.
