Payment Policy:

In order to serve all families fairly and to prevent misunderstanding, RMPA has established a uniform payment policy.

Payment in full is required 48 working hours prior to the furnishing of any merchandise, ceremonies or disposition. Acceptable forms of payment are: cash, money order, cashier's check, Visa/Mastercard. Life Insurance policies MAY be accepted for Roosevelt Mortuary only (Insurance policies are NOT acceptable when only using Roosevelt Memorial Park) under the following conditions:

1. The policy is in force and is assignable
2. The insurance company provides the mortuary with written assurance that they will pay the funeral home and that there are enough funds in the insurance to pay for the contracted arrangements.
3. All beneficiaries of the policy are in agreement and will sign all necessary documents to release funds to the mortuary.
4. That the above be accomplished a minimum of 48 hours prior to the furnishing of any merchandise, ceremonies or disposition.

There will be a \$100.00 processing fee per policy for insurance assignments. Policies under two years old are generally contestable and may not be accepted.

Should a credit balance result from adjustments to the contract, a refund will be issued after the 15th of the month following the month in which services were held to allow time for the processing of any billing adjustments received from outside service providers.

Personal checks, third party checks and credit cards in the name of the decedent will not be accepted.
