We are heading into the final stretch as far as submitting our paperwork for election as precinct committeemen. The paperwork must be in the County Recorder's Office located at 111 South 3<sup>rd</sup> Avenue, Phoenix, AZ 85003 by the end of business on May 30<sup>th</sup>. We will be collecting petitions at the LD 8 meeting on May 10th. After that, the Area Directors will be contacting precinct captains to collect the petitions and affidavits, so we can get them to the County Recorder's Office. I will have copies of all forms that I submit, as well as a receipt from the County. I will send out e-mails alerting you to the last date that I'll be taking the

forms to the County Recorder's Office and then it will be up to you to be responsible for your own paperwork. Please be sure that you fill out the front and back of the petition form.

Also please include your voter ID number on the affidavit form. We will have a notary at the meeting on the 10<sup>th</sup>. The affidavit must be notarized to be accepted. On your paperwork you can use LD 8 and your current LD 8 precinct, or you can use the new LD 23 and LD 23 precinct designation. The County Recorder's Office will accept either. When you receive your ballot you may or may not see your name on the ballot even though you have submitted your paperwork. Your name is only included on the ballot if the number of people applying to be a PC exceeds the number of PC's authorized for the precinct. After the election, the Recorder's Office will publish the names of the elected PC's on their website. As soon as that is published, I will have it published for our information on the LD 8 website. You can also access the County Recorder's Website for the information.

## **SECOND VICE CHAIRMAN – BOE JAMES**

Thank you to Shirley Cordasco and her Committee for all the great work they did to make our breakfast so successful. The food and service was excellent and the auction and raffle items were outstanding. The musical entertainment was superb and something really special.
