# B. Ordinance No. 24 Section 6/ Zoning Ordinance 200 Article XIV Section 14.16

**MOTION** by Jones, supported by Listerman, to approve Amendment of Zoning Ordinance 200, and add Section 14.16.1 Zoning Ordinance Recreational Vehicle and Trailer Storage as follows:

- A. General Storage of Recreational Vehicles, trailers and equipment shall be prohibited in any front yard or any yard abutting a public right—of-way unless permitted in the Article. Recreational vehicles, trailers or equipment shall be placed in the rear of yard or side yard behind the front building line in Residential Zoning District with a minim set back of 3 feet from any lot line with the exceptions noted below.
- B. Screening Recreational vehicles, trailers, and equipment shall be located in such a manner so that visibility for adjacent properties is minimized.
- C. Time Limits. One Recreational Vehicle, Trailer or Equipment may be parked or placed within any front driveway for a period not exceeding 72 hours for loading and unloading or in the process of normal maintenance and cleaning.
- D. Condition and Licensing Requirements, A Recreational vehicles, Trailers, and/ or Recreational equipment stored or parked in any Residential Zoning District shall be licensed and in an operable condition as determined by the Building Official and Zoning Administrator.
- E. Occupation of Recreational Vehicles. At no time shall any stored, parked or placed recreational vehicle, trailer and/or recreational equipment be occupies or used for living purposes. At no time shall such recreational vehicle, trailer and/or equipment have a fixed connection of gas, water, sewer and or electricity.

And repeal Article XIV Section 14.16 and 14.17.
