Dear Country Meadows Homeowner:

You recently spoke with us regarding changes you would like to make to your home or property, or we noticed you have started a project that requires contacting us prior to beginning. If you have begun a project without contacting us, please do not continue without following the proper steps as per the Covenants, Conditions and Restrictions you were given when you purchased your property.

To begin the review process, here's what we need along with the attached form:

- If you are re-roofing, we need a sample of the shingle and the color and weight
- If you are painting your exterior, we need a sample of all paint colors to be used
- If you are adding a room or enclosing a porch, we need all architectural drawings and elevations, paint colors, description of materials and the name and phone number of your contractor, along with the permit number
- If you are adding a swimming pool, we need drawings and elevations of pool cage, along with the name of the contractor
- If you are fencing your property, we need the survey, material, height and a drawing.
- Details on other projects such as satellite dishes, ornate landscaping or exterior lighting, etc.

A few of the items NOT allowed (refer to the Covenants for details):

- Out-buildings such as sheds and enclosed playhouses
- Above ground pools
- Fences taller than six feet
- Addition of a 3rd story

Please refer to your Deed Restrictions for all details.
