2016 Legislative Update

Recently the Legislative Committee had a conference call to outline plans for upcoming Legislative Conference. States will be sent registrations and agenda to outline what to expect in the near future.

Hunter Morehead was on part of the call and stated that right now there wasn't much going on, on the hill. At the moment the Presidential election is taking most of the oxygen. And there isn't much going on in the Ag world at the moment either.



All of the House is up for re-election and ½ of the Senate is up. This will make the Ag Appropriations process move quickly. We are hoping to see a funding piece in the next few weeks.

Current year spending should be ok. Hunter was informed by an area chair that their state office had limited COC meetings and another committee member on the call stated that their state was reporting that CO travel was almost nonexistent while GS travel was adequate. The concern was that CO Managers who did not have AOV's or GOV's available couldn't travel to shared management operations. The consultant was surprised by both of these revelations considering the appropriations. He stated that he would touch base with the administrator and get an answer back to the chair.

The consultant stated that on the House side, there have been several oversite hearings for educational purposes. These hearings are only an exercise to inform members of the House on what each agency within the department does. There will be further hearings in the future to drill down deeper into exactly what each agency does.

The consultant stated that the OPM breach is still an ongoing issue. He stated that he was personally aware of a former federal employee who was a victim of the breach and had \$60,000 debited from her personal banking accounts and the loss was being attributed to the data breach. So our membership should continue to be vigilant.

We need to stay in touch with County Offices to make sure they know NASCOE will look into issues affecting them and their jobs. If any of these items of concerns noted by Hunter are being seen in your state to let us know so we can get the concern addressed by the National Office.

FILL OUT A FSA-444 FOR MEMBERSHIP DUES

As our loyal members begin to retire, we have continued our outreach efforts in an attempt to secure new members. Maintaining membership is always a concern, as we must maintain a 50% membership rate to be recognized as a State Association. This year we have worked with NASCOE National Leadership and the Nebraska State Office to simplify the use of 444's for membership dues and it is our hope that the increased use of the payroll deduction will help to keep our membership more consistent. The number one reason that employees chose to write a check to pay their dues is because completing the NE-FSA-51 and the FSA-444 each year was cumbersome and confusing. We hear you and we agree. Starting with the new dues year in July, 2016 we will be encouraging the use of a 444 that can be filled out one time and rolled over from year to year. The STO has affirmed their support of NASCOE/NEBRASCOE and is willing to work with us in order to reach our membership goals.

So how did we accomplish a 444 that can be rolled over? After months of research, the NEBRASCOE board has decided to implement a fixed rate dues structure based on 0.02% of the employee's salary at Step 5 of their current Grade. For example, all Grade 7 PT's will pay dues at a Grade 7, Step 5 rate. This same rate will stay in effect until the Board votes to adjust dues to accommodate for COLI's, etc. The STO will adjust dues for members who receive promotions but that is the only time you're your dues will increase. One of our concerns is keeping our dues income consistent and as seasoned employees are replaced with new employees, our association income will decrease. We believe that going with Step 5 will help to equalize this amount. As you can see from the chart below, this will mean a very small increase for some employees and a small decrease for others.



Please, do not hesitate to contact a board member if you have any concerns or questions. That's what we are here for, to represent and serve you.

Our dues remain among the lowest in the nation and we are committed to continuing cookbook and shirt sales in order to keep them low. You can help us now by completing an FSA-444 form. Scan a copy to Tracy Hoffman-Ideus at the STO and to Joni Johnson, our NEBRASCOE Membership Chair. This will become effective for PP 13. If we sent the 444's now, it will allow the STO time to process them as they come in rather than dealing with 200+ in July.

Are you thinking about retiring soon? Good for you! Even though your time with the agency may be drawing to a close, we encourage you to continue your membership and a 444 is the most economical way to do that. The FSA-444 terminates after your last pay period so you and your office get credit for your membership but you only pay dues for the pay periods you worked!
