Good morning,

Based on new USDA regulations regarding accommodating special dietary needs, we have created a new form with instructions to be filled out for children requiring and requesting accommodations to their meals.

There are two major changes in the new guidance:

1. The meal accommodations are now required for both children with a disability and a medical need (both require a physician's signature). In general, the definition of a "disability" has been expanded and does not have to be life-threatening to be defined as a disability. It is required that the childcare or daycare home make the accommodation for children with a disability AND medical need if the form is completed and signed by a physician. If the disability causes extreme financial hardship a written plan must be developed with the childcare center or daycare home and the parents or guardians of the child on how the disability and substitution will be handled. The accommodations indicated by the physician do not have to meet meal pattern requirements and can still be claimed as reimbursable.

2. Parents/guardians can complete the form for children requesting meal accommodations and milk substitutions if the child has a medical need that can be substituted within the meal pattern. This substitution **must** be made by the childcare center or home. If the medical need substitution cannot be made within the meal pattern a doctor's note is required.

Parents/guardians can complete the form for children requesting meal accommodations and milk substitutions that are not a medical need but are because of a religious, moral or personal preference that are within the meal pattern. These accommodations **may** be made by the childcare center or home.

Please begin using this form for new special dietary needs requests by October 1, 2017 or before. A parent or guardian of a child that has a special dietary needs form is not required to make a special trip to their doctor just to have the new form completed but should do so the next time they go. Share the form with households, guardians, parents and local physician offices. This form will be posted in Download Forms for future reference.

The new form is attached below with the new guidance that the form is based on.

Instructions for Completing the Medical Statement to Request Special Meals, Accommodations, and Milk Substitutes In Child and Adult Care Food Program and Summer Food Service Program sites

Definitions

- **A Person with a Disability or Medical Need:** a person who has a physical or mental impairment or medical need which substantially limits one or more “major life activities”, has a record of such impairment, or is regarded as having such impairment.
- **Major Life Activities:** can include but are not limited to, caring for oneself, performing manual tasks, seeing, hearing, eating, sleeping, walking, standing, lifting, bending, speaking, breathing, learning, reading, concentrating, thinking, communicating, working and operation of major bodily functions, including functions of the immune system, normal cell growth, digestive, bowel, bladder, neurological, brain, respiratory, circulatory, endocrine, and reproductive functions.

USDA Guidelines	Form Instructions
<p><u>Requests for children with a disability and/or a documented medical need for a meal accommodation:</u> Childcares/agencies participating in federal nutrition programs MUST comply with requests for special dietary needs and for adaptive equipment at no extra charge for children with a documented disability and/or medical need. A completed request form signed by a state-licensed healthcare professional (a medical professional who can write prescriptions) must be provided to the SFA. Efforts should be made for meals with prescribed food substitutions/omissions to meet meal pattern requirements but it is not required.</p>	<ol style="list-style-type: none"> 1. <p><u>Requests for children with a medical need for a meal accommodation that is within the meal pattern:</u> Childcares/agencies participating in federal nutrition programs will accommodate requests for a medical special dietary need if it is within the USDA meal pattern and does not require further clarification or explanation. This includes a USDA-approved milk substitute. Juice and water cannot be substituted for fluid milk as part of the reimbursable meal. However, any student may select a meal without milk under the SFSP OVS. This substitute request can be made by a parent/guardian.</p>	<ol style="list-style-type: none"> 1. Complete Sections A & C. 2. <p><u>Requests for children without a disability or a medical need for a meal accommodation that is within the meal pattern:</u> Childcares and agencies participating in federal nutrition programs MAY comply with requests for preference, religious or moral convictions. Accommodations will be made on a case-by-case basis. Meals provided must comply with meal pattern requirements in order to be claimed.</p>	<ol style="list-style-type: none"> 1. Parent Responsibility:

- Notify the Childcare/Agency of any food allergy, disability or special dietary need.
- Provide the Medical Statement completed by a State recognized medical authority (disability or medical need), or the parent (non-disability, medical need, or preference request).
- Participate in any meetings or discussions regarding the child's dietary needs.
- Notify the school of any changes relating to the special dietary need (a new Medical Statement is required if the diet changes).

Childcare and Agency Responsibility:

- Provide food substitutions for children according to the Medical Statement. The school food service staff may not revise or change a diet prescription or order.
 - Provide training to cafeteria personnel on how to properly accommodate students with special dietary needs. Maintain documentation of the trainings.
 - Communicate with parents, staff, and medical authorities regarding diet modifications.
 - Maintain a Medical Statement on each student with a special dietary need. Diet orders are not required to be renewed on a yearly basis; however, it is highly recommended that the food service confirm that the diet order has not changed. If there are any changes, a new Medical Statement is required. If the school is opting to make a substitution available for non-disabling or non-medical needs, the substitution must comply with meal pattern requirements.
 - Inform parents/guardians of the procedure for requesting meal accommodations and process for resolving disputes related to the meal accommodation request.

- Collaborate with the cook, dietitian, childcare/SFSP sponsor staff, parents and medical authorities to appropriately share pertinent information, obtain a copy of the Medical Statement, and accommodate students with special dietary needs.
