SECOND QUARTER REPORT, 2005 SYSTEM COUNCIL NO. 16 OF THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS

Dear Brothers and Sisters:

This quarter, Assistant General Chairman Jeff Burk completed the Council web site which is now up and going. The quarterly report will be placed on the site for all members to read with the exception of the financial report, which will not appear. This can be found on the "document's page" of the web site. One copy of the complete report will be mailed to the officers as required by the By-Laws.

As many of you are aware, the IAofM (Machinists) have announced the affiliation of their Organization with the BRC/TCU (Clerks - Carmen). With the turmoil in the AFL-CIO and other issues, there are rumors of many other mergers on the horizon.

We are currently hearing rumors that the IAofM has reached a tentative Agreement for National handling relative to the 2000 Section Six notice. I do not have (at this time) any confirmed information to report.

An issue that has been the topic of discussion in the Rail Department recently concerns the payment of per capita tax, both at the System Council level and the International. We have several Locals who are behind and in violation of the System Council By-Laws, Article IX, Section 5 reading as follows:

. . .

" Sec. 5. Any LU indebted to this SC for three months per capita shall stand suspended and cannot again be reinstated without first paying all back per capita unless consent is secured from the EB."

. . .

I am urging all Locals to comply with the By-Laws and Constitution. Those Locals who are in violation of the above referenced By-Law will soon be notified under separate cover of their noncompliance.

Presently there are many new Local officers as a result of elections this quarter. I would ask the Locals to keep the files and documents maintained by the previous officers, most specifically job bulletins, Awards or any other documents that verifies work performed by the Local members. These documents are important should the Carrier assign work once performed by Local members to other crafts.

During the past quarter the Council staff has conducted business or obtained information relative to the following Carriers and Local membership:

Canadian National/Chicago Central and Pacific:

Due to the furlough of the Local Chairman this office assisted in one (1) disciplinary issue.

At the request of the members of Local 939 at Waterloo, Iowa, the Local has been closed and the members transferred to Local 794 in Chicago. Representatives of the Sixth and Eleventh Districts are completing all necessary requirements.

Canadian National/Duluth Missabe and Iron Range:

The discipline case that was to be arbitrated has been resolved to the satisfaction of all concerned. My thanks is extended to Local Chairman Greg Arras for the assistance in this matter.

We are currently investigating an issue with retirement insurance for one (1) of our members.

A claims conference is scheduled for early September to discuss several outstanding claims.

Canadian National/Duluth, Winnipeg and Pacific:

No news to report.

Canadian National/Illinois Central:

The Section Six notices were served on May 2, 2005 as scheduled and the initial conference conducted. During the conference the notice was reviewed and we agreed to discuss it again at a date yet to be determined.

The Carrier has provided several notices relative to the contracting of locomotive work which have been provided to the Locals for investigation and review.

The abolishment of Mechanical Department employees at New Orleans in the first quarter remains controversial as the Machinists remain employed at New Orleans. This matter remains a priority issue for this office.

A claims conference is scheduled for early September to discuss several outstanding claims.

Canadian National/Wisconsin Central:

We have met with the Carrier, conducted several telephone conferences and are relatively close to an initial Labor Agreement. Local members have been advised of details under separate cover. The major outstanding issue at this time is the rate of pay at the Escanaba Ore Docks.

Canadian Pacific/Soo Line:

I have yet to serve the Section Six notice for this round of bargaining. There are still two (2) issues remaining unresolved from the last contract which are the calculation of back pay and the supplemental sickness letter.

We have initiated a claim on a discipline issue for a dismissed employee, obtained information from the Carrier to resolve the Bensenville Shop closure claim and doing some investigation on facts of a number of cases to prepare for final handling or arbitration.

Montana Rail Link:

The coalition continues to meet with the Carrier to obtain a new Agreement. A letter providing information on the status of the negotiations will be sent to the members in the near future.

Lake Superior and Ishpeming:

The coalition has met with the Carrier on the insurance issue and we may end up resolving the Section Six notice in its entirety. A letter will be provided to the Local members providing details of the status in the near future.

Paducah and Louisville:

We have concluded the Section Six handling with an Agreement through July 1, 2008 by ratification of the members on that property.

Elgin, Joliet and Eastern:

No news to report.

NICTD:

We are handling one (1) discipline case, a rules case and have resolved a discipline case to the satisfaction of our member.

We have also completed an Agreement to address the four (4) day ten (10) hour assignment issues for the traveling crews.

Belt Railway of Chicago:

No news to report.

BNSF Railway:

The Burlington, Iowa Shop protection claim was argued and the Award was rendered with the claim denied. The Local will be provided a copy of the Award when adopted. We believe that Arbitrator Peterson erred grievously in rendering his decision in this most important issue. Under the Railway Labor Act the decision cannot be appealed, however at this writing the Council is considering its options to either request an executive session or file a written dissent, which will be attached and become a permanent part of the Award.

We continue to see an increase in the number of discipline hearings, specifically Rule G cases. Once again, I urge you to discuss the serious violations of a Rule G charge and the repercussions resulting from such violation.

The status of the lawsuit relating to the Family Medical Leave Act is dragging along. Documents have been provided to the judge by the parties in December 2004, however there has been no oral hearing scheduled at this time.

We continue to assist our Local officers and members with problems relating to the restructuring of the Telecommunications Department and Omni Trax supervision in Texas.

THIRD QUARTER REPORT, 2005 SYSTEM COUNCIL NO. 16 OF THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS

Dear Brothers and Sisters:

On October 1, 2005, the Director of the Railroad Department, N. R. Cobb, retired. We wish Ray the best for a long, happy and healthy retirement. As of this writing, there is no replacement announced.

We have now had the Council web site for several months and one quarterly report has been posted. I would like to know if our officers and members are using the site and if anyone has any ideas for improving the site. I welcome any comment you may have.

The Machinists' Organization settled the National Agreement by membership ratification. We continue to receive calls from our Locals asking how the Machinists received a better contract than we did. A cursory review by this office does not see it that way, however we are awaiting for a statistical review from the Rail Department, which upon receipt will be distributed to all Locals in our jurisdiction.

During the past quarter the Council staff has conducted business or obtained information relative to the following Carriers and Local membership. Third Quarter Report October 21, 2005 Page Two

Canadian National/IC-CCP-WC-DWP-DM&I:

During the past quarter and after approximately twenty (20) months of negotiations, we finally obtained an initial Labor Agreement for the Wisconsin Central Electricians. The Agreement was approved by the International Office and submitted to the membership for ratification. The Agreement was approved by a vote of six (6) for and five (5) against.

The Agreement places the former WC employees under the IC Appendix A Labor Agreement, establishes seniority at WC locations and provides the Escanaba Dock Electricians a Classification of Work Rule. The Agreement also provides for retroactive wage increases for 2004 and 2005.

We have met with the Carrier and discussed several outstanding claims on the former CC&P, DM&I and IC properties. We are in the process of notifying the Claimants and Locals of the status of the claims.

There have also been some preliminary Section Six discussions. Initially, the parties had discussed placing all of the CN US properties into one Labor Agreement similar to a recently ratified Agreement with the Machinists' Organization, however there are many issues that cannot be easily resolved. We have discussed finalizing the IC-CCP and WC Agreement and perhaps combining the DM&I and DWP, however there are issues here that must be addressed.

The Carrier has a major demand of placing all employees into the National Health Care Plan and in order for the employees to make an informed decision, we are scheduling a meeting in conjunction with other Organizations for a representative of United Health Care to explain the National Plan and answer questions. The employees in Chicago have been notified of the schedule.

Canadian Pacific/Soo Line:

As of this writing we have met twice with the Carrier to review the Section Six notice and discuss movement on the combining and updating of the Telecommunication Department Agreement. A follow-up Telecommunication meeting is scheduled for October 25, 2005. The Carrier has advised that they are considering a Stand-by Agreement for national handling and exploring the possibility of re-entering the National Health Care Plan. I want to emphasize this is only being considered by the Carrier and is not being discussed at this time.

A concern presented about the amount of back pay resulting from the recent Agreement has been answered satisfactorily for the member presenting the question.

An Award has been issued by the Second Division for the dismissal of one of our members. All concerned have been provided a copy of the Award.

A claims conference was conducted on October 12, 2005. The I and M protection case and noon lunch claim for Telcom employees have been finalized and will be submitted to the Second Division of the NRAB for final adjudication. Two (2) other outstanding claims were discussed and need further work before we can move to a Board.

Montana Rail Link:

The negotiating coalition has reached a tentative Agreement with the Carrier and will be meeting in the near future to finalize language. Upon completion, the proposed Agreement will be submitted to the International for approval and if approved, submitted to the membership for ratification.

Lake Superior and Ishpeming:

The coalition met with the Carrier to continue Section Six discussions on August $24^{\rm th}$ an $25^{\rm th}$, 2005, with another meeting scheduled for October $26^{\rm th}$ and $27^{\rm th}$, 2005.

The Carrier has served a notice to contract work, which has been forwarded to the members for investigation and response.

Paducah and Louisville:

The ratified Agreement has been signed and as I understand all members have received monies due. The Carrier is currently revising the Agreement language and when corrected, it will be proofed by this office and provided to the membership.

The Public Law Board Award has been rendered on an outstanding claim and the Claimant and Local notified of the decision.

We are monitoring a STB application for the P&L to acquire a portion of CSX Line to form a new Carrier, Evansville & Western Railway.

Elgin, Joliet and Eastern:

No news to report.

NICTD:

Assistant General Chairman Klecka has been involved in an issue with discipline and a request for training, as well as discussion with the Carrier concerning the 4-10 Agreement and how it will be applied to the members involved.

BNSF Railway:

The Carrier has presented to the Council staff proposals for Traveling Technician positions, their desire for a class of Technicians at the Conditioned Based Maintenance Facilities and the Work Place Observation Alternative Discipline Program. A meeting is scheduled for October 20, 2005 to further discuss these issues.

Many of the Local 418 members at Houston, Dayton, Galveston and Temple were out of work during the hurricane in Texas. Their managers informed them they were going to be paid for the time off and when they were returned to work, told they would not be paid. I understand claims will be or have been initiated by the Local.

There have been a multiple of issues in the Telecommunication Department. Realignment of forces at Alliance, Nebraska and Corwith, Illinois, discipline issues at various locations and recent notification of the Carrier's intent to hire new employees. Assistant General Chairman Mark Klecka met with the Carrier the week of October 12, 2005 to discuss a number of issues.

Contracting continues to be a major issue in the Mechanical and Engineering Department. Several notices have been forwarded to the Locals for investigation. Some have resulted in claims being initiated.

There have been many new employees hired at various locations. I ask that all Locals monitor this closely for compliance with the Union Shop Agreement.

Four (4) Awards have recently been issued by the Second Division. The Claimants and Locals have been advised of the decisions as well as several Awards resulting from discipline issues progressed to the Expedited Board. There are several discipline, rules and protective issues pending on this property.

AMFA members move strike lines into Hastings

The Northwest Airlines air mechanics union strike has hit home, literally.

After being on strike for more than 40 days, members of the Air Mechanics Fraternal Association began picketing outside the homes of union members who have returned to work for the Twin Cities-based airline.

On Saturday afternoon, more than a dozen union members made the trip to Hastings and picketed the home of a Hastings man they say crossed the line recently.

During the picket, union members held bold-lettered signs and shouted taunts of "scab" and "gutless wonder" in the direction of the home on the 3600 block of Village Way, where they say the union member lives.

"This gentleman, he just recently crossed the picket line, and by doing that, we want to let his neighbors know what type of person he is," said striking AMFA union member Ray Hayes, who attended the picket.

No one came out of the house during the two-hour demonstration, but union members said they saw the man look out his window to see what the commotion was about.

Neighbors react

Residents of the relatively new neighborhood who watched the picket from their yards weren't quick to take either side of the issue.

Neighbor Diane Peterson said she doesn't know her new neighbor well but said the picket was probably embarrassing for him to go through.

"We really don't know his situation," Peterson said. "He recently moved into his home, and I'm sure that has something to do with him returning to work. It's gotta be a hard situation to be in."

Tricia Winstead, who watched the picket from her driveway said she wasn't sure how she felt about the issue, but said the picket was a minor nuisance to the neighborhood.

"I'm not against the picketers being out here, but I think this is something that should be kept separated from his home and work place," Winstead said.

Union members have been picketing outside the homes of those who have crossed their line for the last couple of weeks, Hayes said.

"We apologize if we're causing a disturbance to the neighbors, but this is something that needs to be done," Hayes said.

Hastings police were called by one neighbor who said the picketers were blocking traffic by standing in the street,

but no arrests were made, Hastings Police Chief Mike McMenomy said.

"We did send an officer out there to talk with the picketers, but they weren't breaking any laws," McMenomy said. "We're talking with the city attorney to learn how to best handle future situations like this, where there's a protest outside of a home."

Both sides of the fence

Neighbor Will Hilton, who was doing lawn work at his home across the street from the picket, said he wasn't bothered by the picketers.

"I think it's their constitutional right to be out here, as long as they're not on his property," Hilton said.

"I understand the guy has to eat and pay for his new home, but those picketers are probably going through the same issues. It's one of those situations where you're straddling the fence about what to do."

Rural Hastings resident and AMFA union member Kirk Veitzhum said he isn't straddling the fence.

"I know this guy just bought a new house that he's paying off, but a lot of people who are still striking are a lot worse off than he is," said Veitzhum, who picketed the home on Saturday. "He worked with all of us and made the same commitments, but he crossed the picket line. That isn't right."

The initial Wisconsin Central Agreement was signed and there are still a few issues outstanding that we are attempting to resolve.

There is a major issue in negotiations on the DMandI property where the Carrier is demanding termination of a well established pension fund.

This office recently initiated a claim for our members in Local 1475 at Centralia, Illinois relative to turning work once performed by Carrier employees over to a contractor. If any members have further information, please provide to the Local or this office.

Canadian Pacific/Soo Line:

met several times to discuss the outstanding claims Telecommunications Department and the combined Telecommunication Department Agreement on October 11th, 12th, 25th, November 15th and December 15th, 2005. I am in the process of scheduling another date or series of dates to continue these discussions.

We are in the process of negotiating an Agreement to address two (2) issues with the Mechanical Department Apprenticeship Agreement. Details will be provided to the membership under separate cover.

Lake Superior and Ishpeming:

As a result of a request by the employees of this Carrier represented by this office, a coalition of TCU/BRC, IAofM and IBEW representatives negotiated a new Agreement for the employees to maintain their health care network on the Upper Peninsula of Michigan. The Agreement was approved by the Railroad Department, submitted to the membership and counted on Friday, January 20, 2006. The Agreement was ratified by a vote of 5 for 0 against.

Paducah and Louisville:

In the last report I advised that we were monitoring a STB application for the P&L to acquire a portion of a CSX line to form a new Carrier, the Evansville and Western. The Carrier recognized the Agreements of the Organizations on the P&L property and applied the Agreements on the Evansville and Western, in essence a voluntary recognition.

There will be no IBEW represented employees on the property initially as the work will be performed by current P&L employees.

A Carrier representative recently advised that due to this acquisition, there would be a delay in the Agreement update. We will continue to work toward completion of this task.

Elgin, Joliet and Eastern:

The Carrier and its owner, a US Steel Company, have implemented a mandatory metatarsal boot protection program. This program includes all EJ&E employees.

NICTD:

Assistant General Chairman Klecka conducted a claims conference and met with Local officers on December $12^{\rm th}$ and $13^{\rm th}$, 2005. As a result of the claims conference, a discipline issue will be prepared for arbitration.

BNSF Railway:

A look back over past reports reveals the saga continues.

We continue to discuss collectively with the IAofM and BRC an Agreement to establish Traveling Technician positions along the Carriers "Trans Con" route. The details of which we are unable to discuss in this venue, however, at this time there will be twenty-four (24) positions created, divided equally among the Organizations.

This office and the IAofM reached an Agreement with the Carrier for six (6) positions in the Powder River Basin of Wyoming. These positions were created to address downed locomotives and are in essence "rapid responders". The Carrier has indicated there may be more of these types of positions created in the future.

The issues with Omni Trax in Texas have rescinded, perhaps due to the fact the operations manager has been replaced.

Over this past quarter, this office has been notified of several serious matters which have led to the investigation and dismissal, of four (4) members and involved Rule G issues, some which were second offense. I cannot over emphasize that the Carrier is serious about rule compliance and it is up to each of you to comply with the rules if you wish to maintain gainful employment.

As most of you may be aware, the National Mediation Board final quarter funding for arbitration was low and there were very few decisions rendered, or for that matter, arbitration cases argued. Last week we received three (3) Awards from the Arbitrator of the Expedited Board that were submitted the last quarter. Those involved have been notified of the decisions.

Brother Heyland will attend an executive session in late January to discuss the Award rendered in the Burlington Shop protection case.

We are currently attempting to reach an Agreement with the Carrier for a Neutral to arbitrate several protection cases.

A claims conference was conducted with the Carrier on November 16, 2005. Those involved with the claims discussed have been notified of the status under separate cover.

During the investigation into a claim submitted by Local 418, I was advised that the Carrier is leasing its intermodal facilities and associated work to contractors at many locations. If any of you have any information on this, please forward to this office.
