The Board of Directors will hold a public hearing as required by CRS 32-1-1001 (2)(s)(4) on July 18, 2019 to consider an increase in monthly user fees not to exceed \$10 and plant investment fees (tap fees) not to exceed \$2,000. Additional information may be obtained from the District.

#### **Current Fees**

#### Plant Investment Fees (tap fees)

- a. Single family residential including townhomes, condominiums, mobile homes & ADUs: \$5,500/ERT;
- b. Single family residential including townhomes, condominiums, mobile homes & ADUs less than 700 sf: **\$4,125/ERT**.
- c. Single family residential including townhomes, condominiums, mobile homes & ADUs less than 400 sf: **\$2,750/ERT**.
- d. Multi-family residential (apartments): \$5,000/ERT
- e. Multi-family units of less than 700 sf: \$3,750/ERT
- f. Commercial uses: **\$5,500/ERT** based on attached current commercial ERT schedule or projected flows based on engineering analysis or historical data.

**Inspection fee: \$100 per tap;** \$50 per hour for reinspection and inspections of more than one hour.

Monthly User Fee: \$35/ ERT

#### **Equivalent Residential Tap (ERT) Standard**

One (1) ERT is based on 180 gallons per day flow, a five day average BOD<sub>5</sub> of 250 ppm and 250 ppm total suspended solids.
