- Water bills were done over the weekend.

Treasurer Report - Jessica Schneider

Water & Sewer/Streets & Alley Report - Marc Lemrise

- Bathrooms at the park are open.
- Drain tile at Tonica Nursery is fixed.
- A water leak on Rt. 251 on the south end of town was repaired by Pohar & Sons.
- Added dirt and seeded water leak areas around town.

Engineer's Report - Jack Kusek

- The grant for the lift station that was added for the stormwater stabilization lagoon needs to be rewritten and submitted again.
- The road in front of Northern Partners Coop could possibly be fixed by recycling the current road and putting a cement or asphalt overlay on top for around \$54,000.

Attorney's Report - Robert Steele

- Nothing new on sewer treatment easement paperwork.

Trustees Comments & Complaints

- Residents in the area of Elm St. and Peru St. would like a stop sign installed due to higher truck traffic. The board will table it until next month's meeting.
