SEWER APPLICATION  
TO BE COMPLETED BY CONTRACTOR

I, a plumber or private sewage disposal contractor licensed by the State of Illinois and/or the LaSalle County Health Department, certify that I have received a copy of CHAPTER 8 – DRAINAGE of the MUNICIPAL CODE OF SHERIDAN and agree to abide by such including without limit the following provisions:

-Procure public liability insurance in an amount not less than \$100,000 for injuries, including accidental death, to any one person and subject to the same limit for each person in a total amount not less than \$300,000 on account of one accident, and property damage insurance in an amount not less than \$100,000.00. In the event that any work is to be performed on or under a public right of way, the Village of Sheridan shall be named as an additional insured party (not merely a certificate holder). Proof of insurance shall be filed with Village prior to the commencement of any work.

-In the event that any work is to be performed on or under a public right of way, procure a performance bond with corporate surety thereon in the sum of the greater of \$1,000 or 100% of the estimated cost of the work to be done. Such performance bond shall be approved by the Village Attorney and Engineer, conditioned upon the applicant timely completing all anticipated work, restoring of any road, ditch, pavement, sidewalk, or portion thereof damaged during the construction, and indemnifying, saving harmless and agreeing to pay for the costs of defense incurred by the Village for any and all liability and damage arising from the work to be performed.

-File with the Village Plumber Inspector a list of work to be performed supplemented by such plans, specifications, timetable of work, and other information reasonably required by the Plumbing Inspector.

-Allow inspections and pay inspection fees as required by the Village Plumbing Inspector.

-Work shall comply with the building codes as established by the “CABO ONE AND TWO FAMILY DWELLING CODE” and the procedures set forth in that publication entitled *Standard Specifications for Water and Sewer Main Construction in Illinois*, published by the Standard Specifications Committee of the Illinois Society of Professional Engineers, and other similar organizations, third edition.

-All excavations required for sewer work shall be open trench work unless otherwise approved by the Village. No backfill shall be placed until the work has been inspected by the Plumbing Inspector.

-All excavations shall be adequately guarded with barricades and lights so as to protect the public from hazard. Streets, sidewalks, parkways and other public property disturbed in the course of the work shall be restored in a manner satisfactory to the Village.
