Separate permits are required for Electrical, Plumbing, Mechanical (A/C, Heating), Roofing, etc. This permit becomes null and void if work or construction authorized is not commenced within six (6) months, or if construction work is suspended or abandoned for a period of six (6) months any time after work is started. Application is hereby made to obtain a permit to do the work and installations as indicated. I hereby certify that no work or installation has commenced prior to the issuance of a permit and that all work will be performed to meet the standards of all laws and codes regulating construction in this jurisdiction. Job site must be kept clean and orderly at all times. Road and valley gutter in front of property must be swept clean every day.
