1. Meeting called to order by Chairman Dwight Gordon with the following members present: Clifton DeLoach, Willie Frank Thompson, Gerald Blocker and Robert Long.
2. Meeting led in prayer by Mr. Long.
3. Motion made by Mr. Blocker, seconded by Mr. DeLoach and carried not to change the existing zoning of parcel 047-A-011 from Agriculture-Forestry to C-I Neighborhood Commercial. The parcel contains 15.29 acres more or less in Long County. Mr. Gordon voted yea, Mr. Thompson voted yea and Mr. Blocker voted yea.
4. Motion made by Mr. Blocker, seconded by Mr. Long and carried to enter executive session for personnel matters. Mr. Thompson voted yea, Mr. Gordon voted yea and Mr. DeLoach voted yea.
