**Trial Information:** Trial statistics and other pertinent information will be posted at [www.k-9sports.com](http://www.k-9sports.com).

**Move-ups:** The deadline to send in your move-up is Monday, July 30, 2018 at 6:00 pm. Move-ups must be submitted in writing (email ok).

**Height Cards/Measuring:** We will have a VMO available for measuring. All dogs without height cards will have to be measured, including 24" and 24C" dogs. We will have a measuring official available to measure dogs throughout the day.

**Start Time & Running Order:** Check in and measuring time will begin at 7:30 am on all days. However, if you are in Novice and you don't run until the end of the day, you don't have to be here at 7:30am. We will be measuring throughout the day. Just make sure you get your measurement prior to your first run. First dog on the line each day will be at 8:30am. This will be a 2 ring, 1 judge trial. The class running order will be as follows:

**Directions to Key Peninsula Volunteer Park (5514 Key Peninsula Hwy, Lake Bay, WA 98349):**  
FROM NORTH/SOUTH I-5

- Exit HIWAY 16 WEST going over the Tacoma Narrows Bridge along the way
- Exit RIGHT at PURDY DR NW/WA 302 W following the road as it passes under HIWAY 16
- LEFT at LIGHT onto WA 302 (Massimo Restaurant is on corner)
- Follow WA 302 and it will change its name to KEY PENISULA HIWAY N
- 5 MILES further AND the park is on the RIGHT between 58th St KPN and 56th St KPN

**Crating:** There is plenty of space to set up shade tents near the rings.

**B MATCH**

Thirty minutes after the trial ends on Saturday, there will be a B match. A B Match runs exactly like a show, but with no scoring. You may use toys and you can train in the ring. There will be a time limit per run of 90 seconds. The cost is \$5.00 per run. You must fill out an entry form and entries will be taken day of show. The dog does not have to be entered in the show to run in the match.
