

RUSNIK CAMPGROUND SEASONAL INFORMATION

MAY 15 - COLUMBUS DAY

OUR SEASONAL RATE IS **\$2,800** FOR A FAMILY OF UP TO **4 PEOPLE (NO CREDIT CARDS ACCEPTED FOR ANY SEASONAL PAYMENTS)** THE SAME 4 PEOPLE ALL SEASON. YOU CANNOT INTERCHANGE PEOPLE. YOU MAY REGISTER AN ADDITIONAL ADULT TO YOUR SITE FOR **\$150**, OR A CHILD (UNDER 18) FOR **\$100**. ANYONE NOT REGISTERED TO YOUR SITE IS CONSIDERED A VISITOR. WE CHARGE **\$6 PER PERSON FOR A DAY VISITOR** (10AM - 10PM) AND **\$10 PER PERSON FOR AN OVERNIGHT VISITOR** (10AM - NOON THE FOLLOWING DAY). YOU MAY HAVE UP TO 8 PEOPLE ON SITE INCLUDING VISITORS. IF YOU HAVE OVERNIGHT VISITORS, YOU CANNOT SET UP A TENT FOR THEM. YOU MUST BE PRESENT WHILE VISITORS ARE HERE.

YOUR TRAILER MUST HAVE HOLDING TANKS AND A HARD TOP (NO POP UP TRAILERS OR TENTS). IT MUST BE ABLE TO BE REGISTERED FOR ON ROAD TRAVEL. UNDER 400 SQ. FEET. FOR SAFETY REASONS NEW SEASONALS WITH TRAILERS OLDER THAN 10 YEARS MUST PASS OUR INSPECTION PRIOR TO BECOMING SEASONAL.

WE DO NOT HAVE SEWER. WE HAVE 2 DUMP STATIONS. WE HAVE A MOBILE SERVICE THAT GOES AROUND ON MONDAYS. BLACK AND GRAY WATER TANKS WILL BE PUMPED OUT. THE FEE IS **\$25** EACH TIME YOU NEED IT (MONDAYS ONLY). OR YOU CAN PAY **\$225** AND GET PUMPED OUT AUTOMATICALLY EVERY MONDAY.

WE HAVE 30 AMP METERED ELECTRIC ON SITES. YOUR METER WILL BE READ ONCE A MONTH. THE BILL WILL BE CALCULATED USING THE RATE THAT NATIONAL GRID CHARGES US. A NOTICE WILL BE POSTED ON THE MESSAGE BOARD OUTSIDE THE OFFICE WHEN THESE BILLS ARE DUE. WE DON'T HAVE CABLE. WE HAVE A WIFI HOTSPOT NEAR THE OFFICE AREA THAT DOES NOT REACH ANY CAMPSITES.

YOU MAY HAVE A SCREEN HOUSE, BUT NO PERMANENT STRUCTURES ARE ALLOWED. YOU MAY HAVE A DECK THAT IS BUILT IN SECTIONS AND ABLE TO BE MOVED EASILY. IF YOU DECIDE TO MOVE OUT, EVERYTHING YOU BRING IN INCLUDING BRICKS MUST BE REMOVED.

ALL RULES AND REGULATIONS ARE STRICTLY ENFORCED INCLUDING **QUIET HOURS 10PM - 8AM AND FIRES OUT BY 11PM**. PLEASE READ THEM CAREFULLY TO BE SURE WE ARE THE RIGHT PLACE FOR YOU.

YOU WILL BE ASKED TO SIGN A CONTRACT AND LEAVE A \$400 NON-REFUNDABLE DEPOSIT TO HOLD YOUR SITE. AN ADDITIONAL PAYMENT OF \$300 WILL BE DUE FEBRUARY 1. BALANCE PAID BY MAY 1. A LATE FEE WILL BE CHARGED IF PAYMENTS ARE NOT RECEIVED WITHIN 7 DAYS OF DUE DATE. PRICES SUBJECT TO CHANGE.
