**DIRECTIONS to 75 HARTFORD ROAD, SIMSBURY:**

**184:** Take Exit 39 —Follow Rte 4 West, turn Right onto Rte 10 North. Follow Rte 10 to intersection of Rte 44 and continue straight across intersection onto Nod Rd. At end of Nod Rd, turn right onto Rte 185, Folly Farm is a short distance on the Right. **191 North:** Take I84 West and follow directions above. **191 South:** Take exit 40 —Follow Rte 20 to Rte 10 & Rte 202. Turn Left —Follow Rte 10 through Simsbury to Rte 185. Turn Left, Folly Farm approximately 1/4 mile on the Right.

## RULES/REGULATIONS:

1. Every animal entered for competition shall be under the control of show management. The Farm will in no way be responsible for any loss, accident or damage that may occur by fire or otherwise. It shall be a condition of entry that each exhibitor, spectator, trainer and/or attendant hold the Farm and its members, employees and agents harmless for any loss or damage that may occur to any persons, animals or property at the show.
2. If any questions or disputes arise, same will be referred to the steward & show management, whose decision shall be final.
3. Exhibitors are responsible for having accurate and current memberships for all organizations which require responsibility of the exhibitor.
4. There is a \$50 Fee for any returned checks or unpaid entries that must be billed.
5. Entries close 24 hours prior to show start time. Post entries \$25.
6. NO DOGS.
7. Management reserves the right to cancel, combine or divide classes if warranted and due to time constraints.
8. Warm-ups will be held, time permitting.
9. The office fee is \$26.00. If you return your number to be recycled, you will receive a \$1.00 credit.
10. **Please see Time Schedule for classes offered at this show.**
11. Every class offered herein which is recognized by CHJA, CHSA, NEHC or M&S will be conducted and judged in accordance with their rules. To show in CHJA/NEHC Medal classes, riders MUST be members. In order to compete for CHJA, CHSA, and/or NEHC annual year-end awards, the owner of the horse or pony must be a member, and the horse or pony must be registered. Rule Books, class specifications, Medal class specifications and membership applications can be made available at the show secretary's office and/or are available at CHJA.net, chsaonline.com, NEHC.info or M&S.
12. Last off class of each respective hunter division is first round of M&S Classic.
13. NEHC is charging \$2.00 per horse at every affiliated horse show.
14. Blue/Red trips \$20.
