- Marie has talked to AISCA, and Pam has talked to our BRSD support person, as well as a parent from Round Hill who has been through the shift from to public.

- Pam shares that we really want to be an inclusive kindergarten for all. In the fall, our hands were tied so we really felt like we needed to look at going public. But, we now have a new teacher who is willing to stay on, even if she is only part time. We have great PUF funding, which we wouldn't have received through BRSD. Marie has figured out how to get funding, and who to get funding through
  - We now have AISCA behind us who are a great support. They can do teacher evaluations for us.
  - The board is making the recommendation to table to Private vs. Public for now and to remain private.
- AISCA let us know that if there are parents who want to pursue and investigate the private issue further, they can begin that process. The board's responsibility is to run the kindergarten.
- As discussion was made on the topic, a few parents expressed their satisfaction with how things are running. There was some concern about how things might change moving forward if Pam, Marie, and Elise leave their positions, but all plan to stay on for now.
