2) Weed & Maintenance Notifications: Mary Wilkinson

The Board sent 69 Weed & Maintenance Notices July 8th. Effective Aug. 31st there were ten lots sent 3rd notices. Additionally, one lot was sent a 2nd notice and one a 1st notice. A re-inspection this coming week will hopefully find the necessary improvements completed.

3) Pool Project Update: Tracy Leinen

Charlie Charlton donated his labor to replace two (2) Egress Emergency Exit lighted signs in the pool room. An outside light will also be installed by Tri-State Electric when they have a schedule opening. Cement ramp work at the egress doors will be completed soon.

4) Update Street Lighting: Tracy Leinen

Three additional street lights were ordered July 26th. Tri-State Electric will be notified as soon as they arrive. They will install those lights and adjust dimmer switches on existing lights.

NEW BUSINESS

1) Required signatures: Mary Wilkinson

- a. Code of Ethics
- b. Bank Letters of Authorization
- c. Secretary of State records update

Mary advises Board that new signatures are required by the bank to process necessary account changes. Also, Paul Davis must review & sign the Code of Ethics as a new director. The necessary information for the Secretary of State filing will be provided to our accountant for processing. She will meet with Board to complete the paperwork.

2) Vandalism: Tracy Leinen

Tracy advises that we have had some vandalism in the park. The security cameras have captured the activity. Also, entrance was made to the gated water wheel at first pond. The gate was jumped, alcohol was involved and the pump was shut off. If the pump had been damaged the cost would have been approximately \$1,000. She also acknowledges that the Sheriff's Office can be contacted.

3) Activity Committee Announcement: Jan Misch

Jan reports that there is an Ice Cream Social tonight. It is the last event of the year. She thanked those who attended the Taco/Burrito Bar. The 50/50 raffle realized \$55 for the winner and \$55 for the Activities Committee account.

4) Storage Lot Vehicle Wash Access: Tracy Leinen

Tracy reports that owner David Miller suggested utilizing the water faucet in the storage yard for washing vehicles, trailers, atv's, etc. Tracy informs that this is irrigation water so no water usage cost to the park. David Miller will provide hose, fittings and be sure it is working properly. We will try this out and monitor the area. She reminds owners this is a privilege that will be removed if vandalism, theft or improper use is noted.

5) Feeding Wild Animals: Mary Wilkinson

A Public Works Newsletter was in our water/sewer bill this month. There was a reminder of the Feeding Wild Animals city ordinance (Ord. 719-6-13-22). It is unlawful (per City of Cascade Code) to feed wild animals. Livestock, poultry, pets, squirrels or birds other than wild turkeys are excluded. Violations can result in \$ 150 fine. We sent email notifications and had the info posted on our web page so that owners are aware of the ordinance.

BOARD COMMENTS OR OTHER BUSINESS

Mary Wilkinson---An owner requested a covered area for ATV. It is not currently allowed.

Mary Wilkinson--- Requests the Board consider the appointment of Kay Panter to be the Board's representative to the City of Cascade Building Dept to clarify City Building Permit Codes & Requirements that are relevant to LTRV lot improvements.
