Recently you received correspondence from the Regional Income Tax Agency indicating Amelia Village has enacted a 1% municipal income tax effective July 1st 2018 imposed on all individuals and business entities residing, working, or doing business within the Village. Please disregard the previously enclosed **Form 32-EXT** and complete the enclosed Form 32 Declaration of Exemption or Declaration of Estimated Income Tax.

1. **A Declaration of Estimated Income Tax** is an estimate for tax year 2018. If you or your business expects to earn taxable income from July 1, 2018 through December 31, 2018, please complete this form and return it to the address indicated below by September 15, 2018. This form will determine the proper estimated tax due to Amelia Village. Quarterly payments are due April 15th (excluding holidays), June 15th, September 15th and January 15th.
2. **A Declaration of Exemption for Tax Year 2018** - If you or your business is exempt from filing a 2018 tax return based on one of the reasons listed on the form, please complete the form and return it to the address indicated below by September 15, 2018.
