# **Biography:**

Jack Gibbons is Director, Code Advocacy at the Portland Cement Association. He has over thirty-five years' experience in the concrete construction industry. Jack started his career at Master Builders working in several capacities eventually becoming National Account Manager. He then moved to Euclid Chemical where he served as Director of Technical Services, with a focus on educating designers and contractors on the proper use of a variety of concrete specialties as well as providing field service. In 1995 Jack joined Central Ready Mixed, the Wisconsin Division



of Chicago based Prairie Materials, managing the cement laboratory and the Quality Control Dept. While at Central, Jack developed a series of practical high-performance mixes for various applications: low shrinkage mixes for slabs on ground, low heat mixes for mass concrete, high strength concrete for structures and self-consolidating concrete. Some of the notable projects that Jack has influenced include the Al McGuire Center at Marquette University (Concrete Construction, Jan 2001), the Santiago Calatrava designed Milwaukee Art Museum, the 35 story Kilbourn Tower (Milwaukee's first use of 12K PSI high flow concrete), and the 100 story Trump Tower in Chicago (16K PSI SCC). Jack was designated an "Influencer of the Year" by Concrete Construction magazine, and in March of 2013 he was presented with the Richard Stehly Industry Advancement Award by the Minnesota Concrete Council. Jack is a long-time member of ACI and serves on several technical committees, and has been a regular speaker at the World of Concrete. Jack is a Fellow of the American Concrete Institute.
