AMANA NEWS AND NOTES

Prelude Busy and Fun! This Weekend there is More Fun as it's "Kids' Weekend"

Amana's Prelude to Christmas offered some new events and proved to be another big success with almost 6,000 visiting our Tannenbaum Forest.

This year the Amana Art's Guild Christmas Haus Tour included the Ruedy Communal Kitchen with the newly opened Ruedy home a star attraction. Adding to the gaiety was a communal supper Saturday night at the kitchen house featuring a menu like that served in communal Amana on Christmas eve – mashed potatoes, creamed chicken, side dishes and a special dessert. This delighted the folks who came especially for this event.

Another new twist was the appearance of Santa Claus at the High Amana Store. Visitors enjoyed seeing Santa in the store – seated just as he would have been – when Santa first made appearances at the store beginning about World War II.

The Amana Church's Christmas Bazaar and Cookie Walk busted their top record with well over \$7,000 in sales. On-line, pre-ordering of cookie walk boxes and other treats, plus strong, early sales of an expanded Christmas Bazaar helped. This event supports the Amana Church's Sunday School, youth group and the Summer Vacation Bible Camp. Last year nearly 90 children attended Summer VBS. There is no charge for the week-long Bible amp, so funds raised during Prelude pay for all of the supplies, crafts, lesson plan packets, sheet music and food.

"It was a great weekend. It was fun to see what our volunteers created for sale, we had so much variety, and to have so many of our long time supporters and out of town friends stop by to shop," said Carmen Grimm, the church's bazaar co-chair.

Dana Jensen, Amana's Events and Social Media manager, reported to us, "We saw almost 6,000 people through the Forest over the weekend. Overall I would say it was an amazing success. Saturday was a little chilly but the cold can't stop Midwesterners from enjoying all the amazing things that the Amanas' have to offer during Christmas time. So far this is turning out to be our biggest Tannenbaum Forest yet, surpassing records set in 2019."

This weekend Santa Claus will be in the Tannenbaum Forest all weekend long. Santa will appear at the Festhalle on Friday Dec. 9 from 11 till 5 p.m.; Saturday from 10 a.m. – 7 p.m. and Sunday 11 – 4 p.m. On Sunday should the weather be conducive one of Santa's reindeer will be at the Forest from 1 – 4 p.m. Local residents with kids wishing to see Santa at the Festhalle might want to come early or stop by later in the day or evening.

Also this weekend kids can decorate their own holiday ornament at the High Amana General Store from 10 a.m. - 5 p.m. Also at the Indigo Room at the Hotel Millwright you may decorate your own sugar cookie, Saturday Dec. 10 from 3 to 5 p.m. And kids can join in a soda and cheese pairing event at Fire-side Winery in the Village on Main Street all weekend.

The changes are regarding having chickens, ducks and geese on these parcels. The proposed amendment to the ordinances reads as follows:
H. Agricultural uses, including nurseries, greenhouses and truck gardens provided that no offensive odors or dust are created and provided further, that no retail sales or the raising and keeping of livestock shall be permitted on the premises.
I. Chickens, ducks and geese may be kept on the property as long as there are no more than 15. No roosters are allowed. Please reference Iowa County, Ordinance No. 18, for regulations regarding animal welfare and containment. Containment structures shall comply with the applicable district ordinances.
4. Open Discussion Regarding Agenda Item – Purpose of the Public Hearing is to receive input from the General Public regarding potential demolition of property located at 2601 and 2515 J St Middle Amana.
