RULES:

Ride at your own risk. City View Equestrian, LLC, McCormack Properties, LLC and all it's associates will not be held responsible for any injuries to riders, horses, vehicles or spectators. Waivers must be signed.

Per NYS Law 1265, No person less than 18 years of age shall ride a horse unless such person is wearing a helmet meeting or exceeding ASTM F1163. Adults (18+) are encouraged to wear helmets for their own protection, but it is not required.

Proof of current Rabies with 12 months, negative Coggins within 24 months, NYS mandated vaccines within 12 months with proof and Rhino / Flu must be presented BEFORE horses can be unloaded. Over the counter vaccines will not be permitted.

Boots with heel are required to be worn by all participants.

Horses must be in control at all times or the horse/rider combination will be disqualified.

There will be no running of horses in the parking area, driveway or into/out of the gate of the ring. The indoor ring may be used to warm up, but all riders are expected to be in control, respect others and not ride at excessive speed.

"Off course" will be a "no-time" and a knockdown will add a 5 second penalty.

NO DOGS. NO SMOKING ANYWHERE ON THE PROPERTY. Both will result in disqualification and be removed from the property.

No one may enter the barn, touch horses, feed horses, enter pastures, etc.

Rules and Regulations

Show office check list:

-Filled out entry form (blanks can be grabbed day of)

- -Check / Cash / Venmo for entry fees
- -NYS Rabies within 1 year of show date
- -NYS Coggins within 2 calendar years

-Proof of Rhino/Flu vaccine given by licensed professionals (over the counter vaccines given by owners will not be accepted)

- 1. Full payment for class fees and stabling must accompany entries. Cash, Checks or Venmo will be accepted. No credit cards. A \$50.00 surcharge will be added to all checks returned from the bank, regardless of reason. Additionally, exhibitors are encouraged to leave an open check at the horse show office to cover added classes. Otherwise, classes must be paid for as they are added.
- 2. Any accounts not paid in full by the end of the show will be assessed a \$30.00 billing fee.
- 3. All exhibitors will be refunded in full if weather or safety conditions cause show to be cancelled
- 4. Proof of rabies vaccination, dated within 12 months of arrival on show grounds, and negative coggins test results, dated within 24 months of the show date, should accompany entries and payment. In addition, horses stabled outside New York state must submit a valid Health Certificate dated within 30 days. No numbers will be issued until health papers are submitted. Health papers will not be returned. Do not send originals.
- 5. THERE WILL BE A \$1.00 PER PAGE CHARGE TO COPY HEALTH PAPERS IN THE HORSE SHOW OFFICE.
- 6. All riders under the age of 18 are required to wear a helmet with a harness securely fastened that meet or exceed ASTM/SEI F1163 standards whenever mounted.
- 7. Riding in the barns is prohibited.
- 8. City View Equestrian, LLC and its employees/volunteers will not be responsible for any injury, loss or damage incurred to riders, observers, horses, or equipment brought to this show. All riders are at their own risk.
- 9. Each horse/rider combination requires a separate entry number.
- 10. Horses may arrive at the show grounds after 9:30am on day of show. The indoor arena will be open at 9:30am for lunging.
- 11. Management reserves the right to limit the number of horses in the show/schooling arenas at one time.
- 12. Lunging may be done in the INDOOR ARENA ONLY. Lunging in the outdoor arenas is not allowed at any time. Horses lunging in the indoor arena have the right of way. Mounted horses must exit the indoor when lunging horse is working. Lunging may be done in the back field at your own risk
- 13. Riders under 18 are not allowed to ride stallions.
- 14. Weather delays will only be held until 1pm on scheduled day of show. Show will be canceled if class #1 does not start before 1pm. Rain dates will be posted.
- 15. No dogs on the property
- 16. NO SMOKING ANYWHERE ON THE PROPERTY
- 17. Trailer parking will be determined by parking assistants. Parking available in large, grass field at BACK of property, passed the show arena. No parking by the barns or houses will be permitted. Parking on the road is discouraged. Vehicles violating our parking terms will be towed.
- 18. Management reserves the right to deny service to anyone violating Copy Right laws on our photographer's work. Social media accounts using watermarked photos that have not been purchased will NOT be permitted to show on our grounds. Riders using watermarked photos will forfeit all their points (and will not receive them back even after payment is received). Riders using watermarked photos will not receive ribbons or paybacks. Riders using watermarked photos will not receive year end awards.
- 19. A staffed veterinarian will be on call for drug testing. Horses found with illegal substances in their bodies will be reported to the appropriate breed or discipline affiliation.
