Rules: USEF rules will be following to biting, saddlery, and use of tie downs. Riders must wear hard hats and footwear with heels. In addition, vests must be worn by all riders on the cross-country course. \*\*Coggins must be sent in or present upon arrival\*\*

1. Introductory – Intro Test C (jumps 2' mostly logs on ground)
2. Starter – Beginner Novice Test A (jumps 2'3", XC course logs on ground working to roll top, coops, and dog houses)
3. Beginner Novice – Beginner Novice Test A (jumps 2'7")
4. Novice Level – Novice Test A (jumps 2'11")
5. Training Level – Training Test A (jumps 3'3")

6. Intro A, B, or C    7. Beginner Novice A or B    8. Novice A or B    9. Training A or B    10. USDF Training or 1<sup>st</sup> Level Test of your choice
