50th Anniversary Celebration Shoot

September 25th, 2021

Here are the proposed shooting events for our 50th Anniversary.

We are planning on having shooting events for the following disciplines: pistol, shotgun, rimfire rifle, high-power rifle and cowboy shooting.

Event details are subject to change based on participation

Pistol: There will be 2 stages of fire, 5 targets each, on IDPA silhouette targets ranging from 5 -25 yds. Each stage will be timed with 2 shots each target with scoring. There will be classes for rimfire and centerfire, any sights. Required rounds of ammo, 40 rounds each class.

Shotgun: Event will be 2 rounds of trap 25 birds per round. Required rounds of ammo, 50 rounds.

<u>Rimfire Rifle:</u> There will be 2 different types of events.

Event 1 - 50 yard benchrest, 25 bull card in 20 minutes, unlimited sighters, ARA scoring. Any 22 long rifle chambered rifle, any sights, any rest. Required rounds of ammo, 25 plus extra for sighters. One box of 50 will be more than enough.

Event 2 - 3 different stages of NRL22 type firing scenarios. Distances will be from 25 yards to 100 yards. There may be different distances in each stage where you will have to shoot different targets at differing distances. Each stage will be timed for 2 minute max shooting time. All stages will be shot prone, bipods and bags permitted. Each stage will consist of 10 shots. Any 22 long rifle chambered rifle, any sights. Required rounds of ammo, 30 rounds.

High-power Rifle: This event is a bench rest event. Any centerfire rifle, any caliber, any sights, any rest(s). Distance will be 100 yards on a bullseye target (may have more than one bull) with scoring rings to determine score. Course of fire will be 10 shots plus sighters in 20 minutes. Required rounds of ammo, 10 rounds plus extra for sighters.

Cowboy: Event will be 2 stages of differing cowboy related scenarios. Max distance will be 25 yards, will involve shooting different targets at differing distances. Will be a timed event with scoring to include hits and time. Handgun only stages, no jacketed ammo. Required rounds of ammo, 48 rounds.

These are proposed events. In order for each of these events to succeed, we need a minimum of 5 shooters to participate. If we do not have the minimum 5 shooters per event, this event will be dropped from the overall celebration.

There will be awards for those placing in each event, trophies, plaques, certificates.


Date of shoot is September25, 2021 starting at 9 am. Will run until completed before end of day.


All club members will then be invited to a celebratory banquet to be held on September 26, 2021 starting at 4 pm. Again, members only.

Biden Reiterates Call to Ban 9mm Handguns





During a July 21 CNN "presidential town hall," Joe Biden expressed his support for a ban on commonly-owned handguns. Responding to a question about the recent increase in violent crime, the career politician stated,

I'm the only guy that ever got passed legislation, when I was a senator, to make sure we eliminated assault weapons. The idea you need a weapon that can have the ability to fire 20, 30, 40, 50, 120 shots from that weapon, whether -whether it's a 9-millimeter pistol or whether it's a rifle, is ridiculous. I'm continuing to push to eliminate the sale of those things.

Biden's proposed ban on commonlyowned semi-automatic firearms capable of accepting a detachable magazine is unconstitutional. The landmark Second Amendment U.S. Supreme Court case District of Columbia v. Heller concerned a complete prohibition on the ownership of handguns in Washington, D.C. The opinion made clear that the Second Amendment at a minimum protects the right to acquire and possess firearms "in common use at the time" for lawful purposes such as self-defense.

In the context commonly-owned semi-automatic rifles, Heller author Justice Antonin Scalia made clear that the Second Amendment prohibits governments from banning America's most popular rifle – the AR-15. In 2015, Justice Scalia joined Justice Clarence Thomas in a dissent from the denial of certiorari in Friedman v. Highland Park, a case concerning a local ban on commonly-owned semiautomatic firearms. Justice Thomas explained,

Roughly five million Americans own AR-style semiautomatic rifles. The overwhelming majority of citizens who own and use such rifles do so for lawful purposes, including self-defense and target shooting. Under our precedents, that is all that is needed for citizens to have a right under the Second Amendment to keep such weapons.

A ban on semi-automatic pistols is even more at odds with the law. Semiautomatic pistols are America's favorite category of firearm. Moreover, pistols chambered in Biden's dreaded 9mm are the most popular pistol in this category.

At the same time semi-automatic handguns have become ubiquitous, support for a ban on handguns has plummeted. For six decades, Gallup has periodically asked Americans "Do you think there should or should not be a law that would ban the possession of handguns, except by the police and other authorized persons?" In 1959, 60 percent of respondents supported such a ban. In 2020, a mere 25 percent supported this unconstitutional measure.

Perhaps if Biden had spent more time studying, and less time transcribing, in law school he would have a firmer grasp of Constitutional law. As it stands, gun rights supporters will need to educate Biden and his political allies at the ballot box.

OK, Terry, You're Crazy

Virginia Democrat gubernatorial nominee, Terry McAuliffe, got in on the game of comparing guns to other activities by making a ridiculous, and false comment that puts him in the company of Obama.

"Call me crazy, but I think it should be easier to vote than to buy a gun," McAuliffe

- informed message, we are not alone.
- When comparing two constitutional-
- ly-protected rights, neither should
- really be considered "easier" to ex-
- ercise than the other. Amendments including the 15th, the 19th, the 24th
- & the 26th Amendments all
- strengthen and ease the right to vote for everyone.
- But what of McAuliffe's implication that it is currently easier to buy a gun than it is to vote? If he truly believes this, then maybe he is crazy. at the federal level, there has been a steady drive to make voting easier, and the goal has been to remove any restrictions on voter eligibility. In fact, the only real federal
- "restriction" on who can vote is the requirement that one is a US citizen who is at least 18. That's it.
- As for federal restrictions on who can or cannot purchase a firearm? Well, if you are reading this, then you probably know the comparison is like night and day.
- Contrary to Joe Biden's recently debunked claim that the Second Amendment limits who can own what firearms, the numerous federal restrictions on purchasing firearms have been put in place by Congress. Just relating to the purchase of firearms, which is what McAuliffe mentioned, there are any number of re-

quirements and restrictions at the

federal level.



When you go to a gun dealer, you must produce valid identification, fill out a federal form stating you are not prohibited from purchasing a firearm, then wait while a background check is conducted to make sure you are not prohibited from purchasing a firearm.

There are no comparable federal requirements to vote.

There are many people who would be prohibited from purchasing a firearm. Felons, of course, both violent and nonviolent, as well as some with certain misdemeanor convictions. Those with certain mental health adjudications cannot lawfully acquire a firearm, as well as those who have had certain charges filed against them, but have not actually been found guilty of committing any crime. The list of disqualifiers for purchasing a firearm, under federal law, is long, especially when compared to the disqualifiers for voting.

There are no disqualifiers under federal law for voting. You must simply be a US citizen who has turned 18. So, at least at the federal level, there are virtually no impediments to voting, while there are many when it comes to purchasing a firearm. Federal law even allows you to register to vote, and vote, by mail when overseas. Try buying a gun that way. So, at least at the federal level, there are virtually no impediments to voting, while there are many when it comes to purchasing a firearm. 
Maybe Terry was talking about restrictions in Virginia.

Voting in Virginia is neither difficult nor complicated. You can register to vote in a number of easy ways, including online. You can vote absentee by mail, drop off your absentee ballot at a designated location, or go to the polls on Election Day. While some states require a witness sign an absentee ballot to ensure the person voting is the person who is supposed to be casting that ballot, Virginia has removed that requirement.

If you choose to cast your ballot at the polls on Election Day, just show up. While there is an extensive list of acceptable ID you can use to prove you are who you say you are (far more extensive than the list of acceptable ID for gun purchases), you are not actually required to present ID. You can simply fill out an ID Confirmation Statement. Try doing that at a gun store. Speaking of going to a gun store, along with the aforementioned federal restrictions for purchasing a firearm, Virginia a number of its own restrictions on guns that go beyond federal laws. These include restrictions on purchasing firearms, both at gun stores and

privately. So, by virtually any metric available, it is demonstrably "easier" to vote in Virginia, where McAuliffe hopes to again be governor, than it is to purchase a firearm. Whether or not that means the candidate is truly "crazy" may be up for debate. What it does mean, though, is he has no idea as to what the laws are in the Old Dominion where he hopes to be governor (again), or he is being intentionally disingenuous, and simply regurgitating one of the standard antigun tropes so popular within the gunban community.

Reminders...

- There is a hand washing station in the Port-A-John with fresh water (not the blue water), soap & paper towels for everyone's convenience. The fresh water is pumped from the fresh water tank by a foot pump at the bottom of the station.
- While shooting at the 100yrd range, if you are shooting 25yds or less—it is a much safer option to use the 25yd range. This ensures that your rounds will hit the berm and not ricochet into surrounding neighbors property.
