CORRESPONDENCE FROM THE FISCAL OFFICER:

Minutes from the May Meeting being read prior by the Board were approved as read, so moved by Trustee Claypool and seconded by Trustee Ellinger. All were in favor with 3 ayes and no negative votes, motion passed. Met with OTARMA last week to discuss insurance. Will need to complete hold harmless agreements for all contract work. Received two reimbursements from the county fund allocation. Revenues are on par with what was budgeted. A date needs to be set for our budget meeting. Trustee Ellinger motioned to hold the budget meeting on July 2, 2018 at 8:00am. Trustee Claypool seconded the motion. All were in favor with 3 ayes and no negative votes, motion passed. Trustee Ellinger motioned to amend the motion for the budget meeting and add to discuss tree removal. Trustee Claypool seconded the motion. All were in favor with 3 ayes and no negative votes, motion passed.

FIRE DEPARTMENT:

Fire Chief Golden reported that Hocking Township had 331 runs to date. Monthly runs so far have been 410 fire and 35 EMS. There were a total of 10 mutual aids provided to Amanda, Lancaster, and Berne Townships. The AFG grant awards were released. We were awarded the grant to replace all SCBA's and obtain a bottle filling station. The truck grant was denied due to the total age of our trucks not being old enough.

OLD BUSINESS

1. The new ODOT signs are on schedule.
2. The property of Jon and Cathy Born is being worked on with Fairfield County Soil and Water.
3. Trustees are obtaining prices for the old EMS unit for a minimum bid.
4. Jeremy Bigham is scheduled to extend the culvert project on Hopewell Church Road to eliminate erosion.
5. Claypool turned in a quote from Ricketts to complete work on Royaltown Road. Trustee Ellinger motioned to use Ricketts at a cost not to exceed \$3,800.00. Trustee

Motion approved.

7. Trustee Ellinger received the quotes back on the 2018 paving project. Trustee Ellinger motioned to pave Mt. Zion Road and Delmont Road. Trustee Claypool seconded the motion. Roll call vote Ellinger – Yes, Claypool – Yes Motion approved.

NEW BUSINESS:


1. Trustee Ellinger received quotes for a new truck. Trustee Ellinger motioned to use Kaffenbarger. Trustee Claypool seconded the motion. Roll call vote Ellinger – Yes, Claypool – Yes Motion approved.

Trustee Claypool moved to pay the warrants for the month seconded by Trustee Ellinger. Roll call vote Ellinger – Yes, Claypool – Yes, Wolfe – Yes. Motion approved.

There being no further business to discuss Trustee Wolfe motioned to adjourn and Trustee Ellinger seconded the motion.


