Public comments may be made when a Discussion/Action Item is being discussed, provided the visitor raises his/her hand *and* is recognized by the Chairperson.

F. DISCUSSION ITEMS

1. Brief review of FY 2019-2020 Budget YTD and projected year end numbers.
2. Annual discussion of FY 2020-2021 frequency and amount of Director's Fees per Policy 4030.
3. Discuss FY 2020-2021 personnel promotions and associated wage issues that impact the FY 2020-2021 Budget.

4. Discuss COLA increases for next fiscal year. Policy 2150.25.1 dictates previous 12 month CPI percentage as of March 2020 = 2.5%.
5. Discuss proposed District Salary Ranges as adjusted for COLA increase.
6. Discuss Merit increases for next fiscal year. Policy 2150.25.2 dictates maximum combined percentage (COLA + Merit) of 5%. Available range 0% - 2.5%.
7. Discussion of possible and/or significant FY 2020-2021 events and budgetary impact.
 - 7.1 Inflationary pressures. (materials costs, COLA increase, related employee costs, healthcare costs, etc.).
 - 7.2 CLAWA annual fee increase from \$695 to \$2,010 (due to no increases for years).
 - 7.3 Wastewater treatment costs (estimated up \$10,000).
 - 7.4 Fire Dept. dispatch costs up from \$3,988 to \$5,316 per year.
 - 7.5 Workers Comp costs up from \$24,500 to \$33,000 per year (due to claims in the last 18 months).
 - 7.6 Vehicle maintenance up \$1,400 (due to need for new tractor snow chains).
 - 7.7 Managing accounting and audit costs.
 - 7.8 Water maintenance and repairs cost down \$4,000 (due to replacement of older problematic water mains)
 - 7.9 Tax revenues have continued to rise but may decline (unknown COVID-19 impact on property values - assessed tax values).
 - 7.10 Interest revenues are up but may decline (unknown COVID-19 impact on economy and interest rates).
8. Review and discuss FY 2020-2021 Preliminary Income & Operating Expense Budgets for all departments by line item, compare major income and expense variances from FY 2019-2020. (Will be adopted with FY 2020–2021 budget approval action at Regular Board Meeting, June 2020.)
9. Discussion of Projected Allocation of FY 2019-2020 Masterplan Surplus/Deficit and Revenue Surplus Funds to Unrestricted Net Asset Accounts. (Will be adopted with FY 2020–2021 budget approval action at Regular Board Meeting, June 2020.)
10. Discussion of funds allocation to Master Plan Projects in FY 2020-2021 Master Plan/Replacement Budget.
11. Discussion of overall revenues and expenses, funding depreciation/Master Plan costs, and appropriate rates to fund costs. Additional discussion regarding a professional rate study.
