

# The IAABO Junior BOYS Basketball League 2017-2018

Enclosed you will find League Rules, Registration, Waiver, Roster Forms. This information must be completed with any schedule conflicts and **returned by October 21st, 2017. AFTER OCT. 21st, 2017 NO SCHEDULE CONFLICTS WILL BE ACCEPTED. NO EXCEPTIONS. Due to the lack of Gym availability, the IAABO Jr League will be reduced to TWO TEAMS PER GRADE LEVEL for each member school.** Feeders with more than 2 teams for any given grade level may have the opportunity to add an extra team based on the number of teams that sign up. (Enrollment will be open for 3<sup>rd</sup> teams, if space is available, October 28th, 2017) Games will play on Saturdays or Sunday's base on our gym time. (Remember, after OCTOBER 21st, 2017 the IAABO league Director/Scheduler will not re-schedule games, times, or dates around other league/tournament dates/times.)

## Eligibility

All boy competitors, in grades 6TH through 8TH, must live in their member schools attendance areas. **NO EXCEPTIONS. UNLESS OKAYED BY LEAGUE DIRECTOR**

## Registration Fee

Team registration fees of **\$775** must accompany team rosters, and signed wavier forms by the October 21st, 2017 due date. **This will include (2) Tournaments and 10 League games the league cost is \$575 and \$100 per tournament. Tournament cost will be \$150 a piece if you don't sign up at the beginning of the season.** Team provided uniforms/reversible mesh jerseys should be the same color(s) as their designated high school colors.

## League Play

League play will begin Dec 3rd 2017, and continue through February 25th, 2018. Inclement weather "make-up" game dates will be scheduled by League Director.

## League Rules

1. National Federation High School Rules will apply, unless otherwise noted.
2. All boys' teams will use the men's ball (29.5) unless you are 6<sup>th</sup> grade the both coaches must agree on the larger ball. If they can't agree we will use the 28.5 size ball.
3. Teams will use their own uniforms or reversible mesh jerseys. Competitors are allowed to wear T-shirts under their team uniforms/mesh jerseys. The color of the T-shirts must be the dominant color of the uniform. All team members must wear the same colored T-shirt under the uniform/mesh jerseys.
4. **A Zero Tolerance rule will be in affect.** All coaching discipline problems will be reported to the respective high school varsity head coach. **All decisions regarding disciplinary issues will be decided by leagues officials, and the IAABO Board of Directors. The Zero Tolerance rule applies to players, coaches, parents, and fans. Those that do not behave properly will be asked to, and expected to, leave.** In accordance with NFHS rules, **Only ONE coach will be allowed to stand and coach during games. If a coach is EJECTED from a game, he must sit out the next scheduled game (per MSHSAA rules) and must pay the IAABO JR GAC league a fine of \$25. Fine must be paid before the coach can return. Second EJECTION of the season results in removal from the league for that season. Player ejection per MSHSAA rules.**
5. **6<sup>th</sup> grade** games will be (2) **18 minute halves** with a running clock. **7<sup>th</sup> and 8<sup>th</sup> grades** will be (2) **20 minute halves** with a running clock. **The clock will stop on all official whistles only during the last 3 minutes of second half.**
6. In the event of a **20 point lead**, the clock will continue to run during the last 3 minutes of the second half.
7. There will be (2) **30 second time outs** and (2) **full time outs per game.** (4 Per Game)
8. Teams must have 5 players to start a game. The game will be forfeited if the team is not assembled within 5 minutes of the scheduled start time. **There will be a \$25.00 fee for each team that has to forfeit a game.**
9. **If your team is up by 15-Points the NO PRESS rule goes into effect.** (Officials will give one warning regarding the press rule. **Technical Fouls will be awarded after one warning.**)
10. Coaches will be responsible for getting competitor jersey numbers on the score sheet, 10 minutes prior to game time. **Each Team will provide a person to keep the clock or score keeper.** Rosters must be turned in before playing the first game. No amendments will be allowed during the season. (Exception: A student moved in/new to the district.)
11. In the event of a tie in league standings, head to head results will be used first followed by first common opponent results.
12. All over times will be 2 minute periods. Two, 2-minute overtime periods will be allowed. **After the 2<sup>nd</sup> overtime "sudden death" (first team to score wins) will decide the winning team.**
13. All teams will play a 10 game schedule.
14. The Jr. IAABO GAC director/scheduler will decide game times for all make-up games.



**RELEASE, INDEMNIFICATION AND HOLD HARMLESS AGREEMENT**

In consideration of participating in the sport of basketball, and for other good and valuable consideration, I hereby agree to release and discharge from liability arising from negligence H&R Sports Management LLC and International Association of Approved Basketball Officials, Local 173 and its owners, directors, officers, employees, agents, volunteers, and all other persons or entities acting for them (hereinafter collectively referred to as "Releasees"), on behalf of myself and my children, parents, heirs, assigns, personal representative and estate, and also agree as follows:

1. I acknowledge that the sport of basketball involves known and unanticipated risks which could result in physical or emotional injury, paralysis or permanent disability, death and property damage. Risks include, but are not limited to, broken bones, torn ligaments, bruises and other bodily injuries as serious as death, disability or blindness, caused by contact with basketballs, other participants, or structures like walls and bleachers, or caused by slippery, sticky or uneven playing surfaces; medical conditions resulting from physical activity; and damaged clothing or other property. I understand such risks simply cannot be eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the activity.
2. I expressly accept and assume all of the risk inherent in this activity or that might have been caused by the negligence of the Releasees. My participation in this activity is purely voluntary and I elect to participate despite the risks. In addition, if at any time I believe that event conditions are unsafe or that I am unable to participate due to physical or medical conditions, then I will immediately discontinue participation.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Releasees from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity, or my use of their equipment of facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Releasees or anyone acting on their behalf be required to incur attorney's fees and cost to enforce this agreement, I agree to indemnify and hold harmless for all such fees and costs.
4. I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or damage myself. I further represent that I have no medical or physical condition which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.
5. In the event that I file a lawsuit, I agree to do so solely in the state where Releasees' facility is located, and I further agree that the substantive law of the state shall apply.
6. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

By signing this document, I agree that if I am hurt or my property is damaged during my participation in this activity, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence.

I have had sufficient time to read this entire document and should I choose to do so, consult with legal counsel prior to signing. Also, I understand that this activity might not be made available to me or that the cost to engage in this activity would be significantly greater if I were to choose not to sign this release and agree that the opportunity to participate at the stated cost in return for the execution of this release is a reasonable bargain. **I have read and understood this document and I agree to be bound by its terms.**
