Paycheck Deception → Stop Special Interest Now → Stop Special Exemptions Act 98% of most private businesses do not have automatic payroll deduction PACs. The real intent of these legislative initiatives is to hinder public safety associations in their efforts to establish/maintain PAC accounts. We have to get the word out to our own members the importance of maintaining the ability to contribute to and maintain PACs by our associations. Desert Hot Springs Taser Case – Officer recently convicted on two counts of "deprivation of rights under color of law". At the center of the issue was a claim that deployment of taser was excessive due to minimal time between bursts to allow for compliance.

Fullerton 6 – Prelim was May 8th. Mother of deceased has already settled, however father is still pushing his civil case.

Fullerton case, Prelim went very well. There is concern that public pressure is pushing for more officers to be charged. Because this is as much a political issue as it is a criminal/civil issue, this is a highly charged case, and a lot of misinformation. LDF is an invaluable resource because it provides protection/assistance when issues like this arise, particularly those that are politically charged. In those situations, the correctness of the officer's actions are rarely the focus.

LAPD recently established a new policy where officers where downgraded from specialicedpay positions by establishing new criteria.

C. Retiree Medical Trust

Cities and Counties are currently trying to take many of our benefits, as we all now. One of the biggest targets is lifetime medical. A potential focus for associations, during next round of negotiations, is participation by employing agency in the RMT. This is a great way to supplement future employees for those agencies being forced into a 2 or 3 tier system. Assets continue to grow... Currently at \$9.8M.

Minimum requirement is \$100/mo per employee...Vesting occurs at 5 yrs.

Annual Scholarship committee meeting held recently. Tri-Counties has 4 recipients of \$1500 Scholarships: Alexis Wilson, Jim Graham, and Lauren Whitman, Jessica Cochran.
