B. **CTA Sick Bank**

C. **Janus vs AFSCME**

The Supreme Court usually issues their decisions on Mondays. However, *as we get toward the end of June when the Supreme Court's current term ends, decision days can be added with as little as 24-hours' notice. There may be more decision days added this week. Since the court does not give advance notice of which opinions it will issue on any given decision day, we will not know when the Janus decision will be released until that day.*

D. **APPR and Senate Bill 8301**

The same bill was already passed in the Assembly. Now it is time for our Senators to do the same. The bill is to permanently decouple 3-8 testing from the APPR and give back local control of APPR.

To date the bill has been sponsored by 55 of the 63 members of the Senate, including all of the Democrats and a majority of the Republicans. Now, the Senate Majority Leader must bring the bill to the floor for a vote.

E. Long Beach School District Calendar

The School Board has made a request for the Superintendent revisit next year’s calendar as it relates to snow make up days. The current policy is, in the event more than two days of instruction are lost due to school closings, those days which exceed two will be made up. This will not change, however they would like to change the days that have been designated. Currently the make up days in order are 5/24/19 and 4/26/19. They would like to add two days and change the order to 5/24/19, 4/18/19, 4/19/19 and 4/26/19. After a lengthy discussion the Executive Board has approved the change. It is projected that the school board will accept these changes at their 6/14/18 meeting.

G. Local CTA Dues

As per our constitution I may recommend that the Executive Board approve a local membership fee increase. After a thorough review of our finances by our treasurer, I believe this will not be necessary for next year. In addition, at the NYSUT RA in April, we passed a motion for NYSUT not to increase dues for next year. I believe the AFT will try to do the same. As a result our dues at the local, state and national level should all remain the same for next year.

H. Sell-back of Health Insurance

If you have elected to “sell-back” your health insurance, you should have received your second half payment as part of your June 8th paycheck. Please keep in mind that even if you “sell-back” your medical insurance you are still entitled to family dental insurance.

I. Eyeglass Reimbursement

We are in year two of a new two year cycle for eyeglasses/contacts purchases. Members have \$400 to spend on glasses/contacts. On the form you will attest that the glasses are for your personal use. Completed [claim forms](#) with receipts attached must be sent to the HR department.

K. NYSUT Leadership Training

NYSUT will be holding workshops and conferences throughout the 2018-19 school year. Their new “core curriculum” approach recognizes the changing role of the building rep and will equip building reps with the basic skills they need to do this work effectively. With the exception of Frontline 1 and 2 which they recommend be taken sequentially, these workshops do not have to be taken in any particular order. L. Pay Options

Each year you have three pay options:

- 21 equal bi-weekly payments (September through June),
- 25 payments; 21 payments (September through June) + 4 payments on the last day of school
- 26 payments; you will receive 1/26 of your annual salary every two weeks from the first

pay date in September through the last pay date in June when you will receive the remaining paychecks as separate checks, all dated June 30, which you may deposit at any time from June to August. Direct deposit will not be available for the last six paychecks. All deductions will be spread out over the 26 pay checks.

M. Annual Turn-In of Sick Days

If you have accumulated at least 75 sick days and wish to exercise your option of selling back unused sick days earned this year (up to 12 or 14 if you worked at Summer School) you must submit a “[Request for Payment in Exchange For Accumulated Unused Sick Days](#)” form to Dr. Natali’s office. The rate is \$94.69 per day. Please be aware that you can accumulate up to 200 days in your sick day bank. Any days in excess of 200 should be sold back to the district.

N. Packing and Unpacking

If you are directed to pack up your room in anticipation of construction, summer school or summer camp you are entitled to be compensated for your efforts. The rate is \$25.46 per hour. However, your claim cannot exceed \$100. The work must be done outside of the school day and a record kept of the dates and times you worked.

II. Committees

A. Grievance Committee—Karen Bloom

1. There are no grievances to report at this time.

B. Negotiations—Keith Harvey, Chief Negotiator

As you will remember, at the conclusion of our last negotiations we agreed to continue negotiating the sick bank and I told you I would bring it to the Executive Board and then the general membership for your approval. At this time we have come to an agreement with the district. The items listed below were approved by the Executive Board. We will have a special membership meeting on Tuesday, September 4, 2018, at 8:30 AM for the purpose of presenting and ratifying these items.

Eligibility

Must be a dues paying member, employed by the district for four years. Members shall be limited to an aggregate of 20 days multiplied by the number of years of service actually performed in the District as a member. Limit is still 200.

Targeted Days

The district may allow unit members to voluntarily donate sick days to another specific unit member whereby all of his/her accumulated sick days have been depleted.

Limit Number of Days

Members shall be limited to an aggregate of 20 days multiplied by the number of years of service actually performed in the District as a member, not to exceed 200 for the duration of their employment.

Serious Illness

Days will only be granted to members that qualify under the FMLA Serious illness definition. A new form will be created that will confirm the above.

III. Executive Vice President's Report—Karen Bloom

A. Elementary and Secondary Letters

1. Much of the information that was stated in both the elementary and secondary letters sent to parents came as a surprise to many teachers. Although it was stated that these decisions were the work of the curriculum committee, the majority of these topics were not discussed or agreed upon there. We are hoping that in the future, major changes to our curriculum and/or policies can be discussed with all parties involved before sending information home to parents.

2. In addition, for the secondary letter, we are hoping that administration realizes that middle school and high school are two very different places. What works in one building may not work in the other. Before jumping into any major policy changes, we need to consider the students and the effect that some of these changes may have on them. For example, when we encourage students to challenge themselves by taking a higher level IB class and then remove participation and/or homework from their grades, the students will suffer and may choose not to challenge themselves anymore. Or take a special education/ELL student who is struggling to pass Living Environment, but does all of their homework, participates in class and works very hard, but cannot pass tests. If we remove those other components, that student can now fail the course, and falls behind, jeopardizing graduation.

3. We welcome any and all conversations regarding these topics, and hope that all parties are considered when making such important and influential decisions regarding the future of our students.

B. APPR

1. Be sure to check your end of the year calculations of SLO's with your supervisor. Remember that we can only challenge composite scores that are Developing or Ineffective.

2. There are many teachers that have reported they did not have all of the evaluations that they should have, or did not get feedback from observations that took place. This is NOT something that you need to worry about. Administration will either calculate it as is, or will need to report it as "administrative error". However, we will also discuss the importance of feedback with administration. Just as they would like us to provide feedback to students in a timely manner, it would be helpful to teachers, especially new teachers, to receive feedback as well.

3. Unfortunately, people were still getting observed during the last few weeks of classes. We are looking to discuss an end date with administration, as these last few days do not always provide the best snapshot of a teacher. Most classes are reviewing at this time which is very different than a typical lesson.

4. Our APPR handbook is on our website. You can find all timelines, conversion charts and percentages here.

5. Now that Regents exams are being weighted differently, we may want to rethink the methods in which we chose to calculate our growth scores.

6. Feel free to contact me if you have specific concerns regarding APPR.

C. Health & Safety Committee and District Safety Team

1. Although the last meeting of the year was cancelled, I was able to get an update on a few items from Mr. DeVito.

2. The traffic consultant is completing the final draft of the study including recommendations. There was a recent meeting with the consultants and the Lido Civic Association.

3. There was a kick-off meeting on Tuesday, June 4th for the summer work specifically the north wall at West, roof and façade work at Lindell and the rear window replacement at East.
4. Since all of the proposed capital projects were approved either through the 2018-19 budget, Proposition #1 or Proposition #2, our architect has already started to file the paperwork with SED so we can receive permits and requisite approvals to begin the work.
5. The district is still waiting to receive the test results in order to decide how our insurance carrier will be handling the replacement of the middle school auditorium ceiling. They expect to receive the critical information next week.
6. Communication: We have still not had anything put into place to resolve the issues at the high school regarding rooms that do not have an intercom or a phone.
7. We are hoping that much of the proposed work gets completed this summer and we are looking forward to hearing about all of the updates in September!

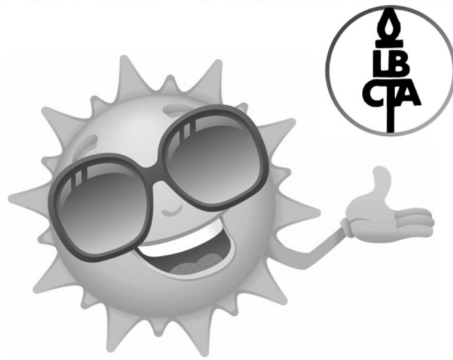
