## Minutes of May 20, 2019

The Huntington Township Trustees met in regular session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Jed Lamb. Also present were Walter Rollin, Robert Holmes, Dennis Finkel, Dimitri Szynal, Carl Strekely and Sheila Lanning.

*Motion* by Rollin with a second by Holmes to approve the minutes of May 6, 2019 regular scheduled meeting as written. Roll call: 3 yeas.

**PAYMENT LISTING:** Checks 8690- 8703 and expenditures totaling \$34,644.61 approved for payment.

#### Water Board-

**LORCO-** Lamb stated they are doing a good job of paying people back. Paid some back to L.M.R.E.

**Ambulance District-** Received one resignation, marking handicap parking spaces. Replaced a furnace in the little section. Still looking at new sign but will not be an electric one. Hired one employee and let one go.

**Fire District-** Meeting 5/21 to talk about getting a grant.

**OPWC-** Finkel attended and was mostly re-appointments.

**SWAC-** Moving along on Griggs Road project, Lanning re-sent invoice to Don Romancak with the County PO#.

**Zoning Business/ News-** Tomorrow will be Zoning Commission Public Hearing on 3 Zoning Amendments. Finkel- inquiry from Jerry Largent about switching property zoning to Business Commercial on Route 162. Wishes to move his small business to this location. Also received one home conditional use application.

**Thrive-** sending information to put on Township Facebook.

**Cemetery-** Looks good for Memorial Day, Walt and Szynal to look into getting a grant. **Road/ Equipment/ Maintenance- Finkel**: Still no word on repairing Baker Road from Melway. Roadside mower needed \$878.33 in repairs. Received letter that the bids are awarded by the County for 2019 chip and seal at \$60,471 for 4 miles. No further word from railroad on fixing the crossing. Railroad inspector said it looked fine, Finkel disputed the condition and they will look at it again.

**Recycle-** Dumpster day went well with lots of scrap being brought in. Thank you to everyone for all the work. The concrete outside the building looks good.
