# WILLIAMSON COUNTY EMERGENCY SERVICES DISTRICT #2 MINUTES OF THE SPECIAL MEETING – April 30, 2020

ITEM 4: Review 2019 Audit of Williamson County ESD #2.

Day presented the results of MGSB's audit of the District's 2019 financial records. The audit resulted in the District receiving an unmodified opinion, the best opinion that can be given. No issues need to be addressed. The Management Letter notes the absence of a District capitalization schedule, but MGSB determined that would be expensive to prepare. Note 11 in the draft regarding uncertainties is standard language now being included regarding the COVID-19 situation.

ITEM 5: Discuss and take action, as may be needed following receipt of Annual Audit.

Commissioner Baltazor inquired about obtaining a list of District assets. Commissioner Nanninga said such a record has been compiled and will be included in the District documents that are waiting to be digitized.

Day said the draft audit was sent to Legal Counsel Mark Dietz and that Dietz has not made any response. Commissioner Nanninga requested Day send the finalized audit directly to him for presentation at the District's next regular business meeting. Once approved by the District board, Nanninga will send the document electronically to the Williamson County Auditor and to the Precinct 1 Williamson County Commissioner.
