## Next, we'll ask Criminal History Questions

- Yes  No Are you currently the subject of pending arrest warrants, prosecution, or proceeding for an offense or action that could lead to the disqualification to own or possess a firearm?
- Yes  No Are you currently the subject of an existing Order of Protection or No Contact/No Stalking Order?
- Yes  No Have you ever been in residential or court-ordered treatment for alcoholism, alcohol detoxification, or drug treatment within the 5 year preceding the date of this application?
- Yes  No Within the previous year, have you failed a drug test for a drug for which you did not have a prescription?
- Yes  No Are you addicted to narcotics?
- Yes  No Are you a medical marijuana card holder, grower or distributor?
- Yes  No In the past 5 years, have you been a patient in a mental institution or any part of a medical facility for the treatment of mental illness?
- Yes  No Have your ever been adjudicated by a court as a mental defective or ordered by a court, board or authorized entity to an in-patient or out-patient mental health, alcohol or drug treatment program?

- No hats, sunglasses or other accessories that obscure your face
